Procurement Management Services, at the request of the Office of Facilities and Design, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract, at firm unit prices, for specialized industrial/commercial services for the relocation, assembly and installation of logistics of specific projects as required for the GOB-General Obligation Bond, Capital Improvements, Schools Operations, Maintenance Operations projects and/or any District-Wide administrative requirement at the various Miami-Dade Public Schools Facilities. This ITB was advertised on the Procurement Management Services and DemandStar websites. The solicitation was shared with District offices for additional community outreach, and its various media platforms, including but not limited to social media, local radio stations, and prior bid forecasting lists.

The initial term of the bid shall be for a period of three (3) years, commencing January 15, 2020, through January 14, 2023, and may, by mutual agreement between the School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods.

Strategies were employed to increase SBE/MBE (Small/Micro Business Enterprise) participation. The Goal Setting Committee recommended that this solicitation be open with a 5% SBE/MBE preference rate.

Three (3) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract will be awarded to three (3) vendors.

M-DCPS OEO staff verified the SBE/MBE certification status of the prime firms and all subcontractors.
