# LINK TO STRATEGIC BLUEPRINT: EFFECTIVE AND SUSTAINABLE BUSINESS PRACTICES

Introduction:

In September 2019, a Request for Qualifications (RFQ) 175 was published to competitively select one or more Energy Services Companies (ESCos) for GEPC Part 1 Master Agreement and assign the Representative School (Miami Coral Park Senior High School) to the top-ranked ESCo as an amendment to its GEPC Agreement, per School Board Policy 6330, *"Procedures for the Selection of Guaranteed Energy Performance Contract (GEPC) Services Firms"*, updated August 14, 2019 (Selection Procedures).

Four (4) firms responded to the solicitation and were evaluated. Three (3) firms were short-listed and invited to a walk-through of the Representative School to develop an Investment Grade Energy Audit (IGEA). The IGEAs were reviewed and scored for technical compliance by a Technical Review Team. On January 30, 2020, the short-listed firms were interviewed and subsequently ranked by the Selection Committee, as follows:

- 3 Ameresco, Inc. (Ameresco)

Representatives of the Office of Management and Compliance Audits validated the interview scoring calculations and final tabulation. Jasmine Zhang, Professional Selection Analyst, of A/E Selection & Negotiations, acted as the Facilitator (non-voting) for the interviews and served as Chief Negotiator during negotiations.

#### Selection:

All three (3) firms were selected for the GEPC Part 1 - Master Agreement. Trane was the highest-ranked firm and, in accordance with the Selection Procedures, was assigned Miami Coral Park Senior High School.

#### Services:

GEPC services require the ESCos to be fully responsible for performing IGEA (analysis to identify Energy Conservation Measures (ECMs)), design, construction, 12 years of maintenance and Measurement & Verification (M&V) of ECM(s), and include an energy cost savings guarantee. The ESCo team must consist of an Architect, Engineers, M-DCPS pre-qualified Construction Contractor and M&V professionals.

GEPC services will be negotiated and commissioned in two parts, as follows:

**PART 1** - GEPC Master Agreement services and representative school assignment: The selected ESCos will enter into a GEPC Master Agreement. The top-ranked firm will be assigned the representative school and invited to negotiate for the first GEPC Amendment. ESCo(s) shall commence the IGEA process for project assignment(s) upon Board commission.

The IGEA for each school shall be in accordance with the requirements in the GEPC Agreement, ESCo Special Conditions-1, State Requirements for Educational Facilities (SREF), the Florida Building Code (FBC), National Fire Protection Association, Florida Fire Prevention Code (life safety), barrier-free design guidelines, Florida Statutes, and District Standards and Policies.

#### **PART 2** - Project-specific GEPC Amendment:

Once an IGEA has been evaluated, negotiated and an agreement reached on an individual school project, A/E Selection and Negotiation will submit a recommendation to the Board outlining key negotiating points such as GEPC services, design, scope of work for construction of agreed-upon ECMs, maintenance and M&V for 12 years, project

schedule, payment schedule, whether the prime firm is a Small/Micro Business Enterprise (S/MBE) and/or Minority/Women Business Enterprise (M/WBE), and a list of S/MBE, M/WBE sub-consultants, including required mandatory goals, in compliance with School Board Policy 6320.

### Office of Economic Opportunity (OEO) Review:

**PART 1** - There are no mandatory S/MBE or M/WBE sub-consultant goals for the IGEA and design services on the representative school (Miami Coral Park SHS).

**PART 2** - Mandatory sub-contract goals for construction and Local Workforce Utilization will be determined for Miami Coral Park SHS once the ECM/project scope is finalized and prior to negotiations. The goals for other potential GEPC schools will be determined once the ECM/project scopes are finalized and prior to negotiations (on a project-by-project basis).

M-DCPS' OEO staff has reviewed and verified the following:

- 1) SBE or MBE Certification status of the prime ESCo firms;
- 2) M/WBE Certification status of the prime ESCo firms;
- SBE or MBE and M/WBE Certification status of all prime ESCos' sub-consultants; and
- 4) Copies of Memoranda of Understanding with each sub-consultant of every prime ESCo firm, outlining roles and responsibilities of the sub-consultants.

Terms & Conditions:

- The ESCo has agreed to the terms and conditions of the Master Agreement and will commence PART 2 services upon Board commission.
- Individual school projects will be assigned for the IGEA services. The ESCo firm shall negotiate for ECM(s) to be implemented and installed at the facility, scope of GEPC services to be provided (including but not limited to design, installation, training, operation and maintenance), energy cost savings, guaranteed energy cost savings, M&V protocol, ESCo's compensation and payment schedule, and other term of GEPC services. If accepted, staff will submit the GEPC Amendment for Board approval.
- The ESCo shall maintain no less than a \$1,000,000 Professional Liability Insurance practice policy with a maximum deductible of \$50,000, Workers' Compensation/Employers' Liability Insurance, Commercial General Liability Insurance, and Automobile Liability Insurance, all as specified in the Agreement.

- The Agreement may be terminated by the Board by written notice when it is in the interest of the Board and the sole discretion of the Board; whereas, the ESCo may terminate the Agreement by written notice to the Board within thirty (30) calendar days after Notice of Non-Appropriation is delivered by the Board.
