SUBJECT: REVIEW OF POTENTIAL LIABILITY IMPACT OF THE COVID-19 PANDEMIC ON MIAMI-DADE COUNTY PUBLIC SCHOOLS

The COVID-19 pandemic has forced school districts to put many of the teaching and learning activities on a different path. While students and their parents may have made peace with online learning for the remainder of this school year and perhaps beyond, many still feel unprepared and continue to be concerned about the health and safety of their children.
