Procurement Management Services, at the request of the Office of Community Education and Before/Aftercare Programs, released the above-referenced solicitation. The purpose of this Request for Proposal ("RFP") is to establish a list of pre-approved firms that are eligible to provide state licensed before and after school child-care services on-site for elementary schools, K-8 centers, middle schools and centers for special education. This RFP was advertised on the Procurement Management Services', BidSync and DemandStar websites. The solicitation was shared with District offices for additional community outreach, including but not limited to social media, local radio stations and prior bid forecasting lists.

The initial term of the bid shall be for a period of five (5) years, through an Affiliating Agreement to be approved annually, commencing September 9, 2020 through September 8, 2025, with one (1) five (5) year option to renew and if needed, an additional ninety (90) days beyond the expiration of the renewal period, at the District's discretion.

Strategies were employed to increase SBE/MBE participation. The Goal Setting Committee recommended this solicitation be open.

Five (5) vendors responded to this advertised bid. Based on the criteria listed in the solicitation and the recommendations from the Selection Committee, the contract shall be awarded to five (5) vendors, pending contract negotiations and execution. The negotiated affiliating agreement will include the waiver of facility usage fees, replicated M-DCPS fees, selected locations for each awarded vendor, and general terms and conditions.

M-DCPS OEO staff, as represented as one of the voting members of the Selection Committee, verified the Small, Micro, Veteran and/or M/WBE certification status of the prime firms and all subcontractors, as applicable.
