Of the 34 charters schools listed in the preceding table, 33 charter schools appeared to be free of significant fiscal issues. The remaining is the close-out financial statement audit of the Latin Builders Association Construction and Business Management Academy. During November 2019, the school voluntarily terminated its charter school contract, ceased all charter school operations on November 29, 2019, and issued its final close-out audit on March 16, 2020. We are bringing this information to the Audit and Budget Advisory Committee for their information, discussion, and recommendations to the School Board.

The School Board Audit and Budget Advisory Committee will review these financial statements at its December 1, 2020, meeting to consider their transmission to the School Board.

Copies of these financial statements will be distributed and placed on file in the Office of the Recording Secretary to the School Board and in the Citizen Information Center.
