Procurement Management Services, at the request of the Office of School Facilities, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract, at firm unit prices, to purchase face shields and protective suits for Miami-Dade County Public Schools. This is a term bid states that the Board may purchase services, as may be needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website, as well as Periscope and DemandStar. The solicitation was shared with District offices for additional community outreach.

The initial term of the bid shall be for a period of one (1) year, commencing December 10, 2020 through December 9, 2021, and may, by mutual agreement between the School Board of Miami-Dade County, Florida and the successful bidders, be extended for one (1) additional one (1) year period.

The Goal Setting Committee assigned an SBE/MBE sheltered market for this solicitation.

Twelve (12) SBE/MBE vendors responded to this solicitation. Based on the criteria listed in the ITB and School Board Policy 6320, *Purchasing, (X) Identical Prices/Points--Priorities for Award*, the contract shall be awarded to five (5) SBE/MBE certified vendors, four (4) of which qualify for local preference.

For face shields and protective suits, the District spend \$11,543 in Fiscal Year 2019-2020 and \$233,968 to-date for Fiscal Year 2020-2021.

M-DCPS OEO staff verified the Small, Micro, Veteran, and/or M/WBE certification status of the prime firms and all subcontractors.
