Procurement Management Services, at the request of the Stores and Mail Distribution Warehouse, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract with pre-approved vendors, to purchase medical supplies for Miami-Dade County Public Schools (M-DCPS). This ITB was advertised on the Procurement Management Services website, as well as Periscope and DemandStar. The solicitation was shared with the District offices for additional community outreach, and its various media platforms.

The initial term of the bid shall be for one (1) year, commencing January 13, 2021 through January 12, 2022, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for one (1) additional one (1) year period.

The Goal Setting Committee sheltered this ITB for SBE/MBE certified firms.

Eleven (11) SBE/MBE vendors responded to this solicitation. Based on the criteria listed in the solicitation, the contract shall be awarded to eleven (11) SBE/MBE certified vendors
