Procurement Management Services, at the request of Facilities Operation-Maintenance, released the above-referenced solicitation. The purpose of this invitation to bid is to establish a list of preapproved vendors, with licensed Florida General and Building Contractors, to participate in addressing reactive and proactive health and safety-to-life deficiency repairs, and/or proactive miscellaneous building repairs and renovation work. These deficiencies will be identified on an ongoing, school-by-school basis. This ITB was advertised on the Procurement Management Services website, as well as Periscope and DemandStar. The solicitation was shared with District offices for additional community outreach and its various media platforms.

The initial term of the bid shall be for a period of two (2) years commencing January 13, 2021 through January 12, 2023, and may, by mutual agreement between the School Board of Miami-Dade County, Florida, and the successful bidders, be extended for three (3) additional one (1) year periods.

Ten (10) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract shall be awarded to ten (10) vendors, six (6) of which are certified.

In Fiscal Year 2019-2020, the District spent \$1,089,568 on maintenance inspection deficiencies repairs and renovations contractors.
