SUBJECT: AWARD INVITATION TO BID NO. ITB-19-029-MV – VACANT LOT MAINTENANCE - MOWING AND FENCE LINE CLEARING

Procurement Management Services, at the request of Facilities Operations, Maintenance, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish contracts, at firm unit prices, for fence line maintenance, lot maintenance, tractor mowing, mechanical clearing, and the collection, removal and proper disposal of bulk trash and debris, as needed, for the various schools and departments in Miami-Dade County Public Schools. This is a term bid which states that the Board may purchase services, as may be needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website, as well as Periscope and DemandStar. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a period of three (3) years, commencing February 10, 2021, through February 9, 2024, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods.

The Goal Setting Committee did not assign an SBE/MBE preference for this ITB.

Ten (10) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract will be awarded to three (3) vendors, of which one (1) is MBE/MWBE certified.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s).

In Fiscal Year 2018-2019, the District spent \$249,688 on vacant lot maintenance – mowing and fence line clearing.
