THE CONSTRUCTION MANAGER AT-RISK SHELTERED MARKET, MICRO BUSINESS ENTERPRISE AGREEMENT UNDER THE SAME FEES, TERMS AND CONDITIONS AS THE ORIGINAL AGREEMENT, AS AMENDED, FOR MISCELLANEOUS PROJECTS WITH CONSTRUCTION BUDGETS UP TO \$200,000 EACH, WITH LLORENS

The District has elected to exercise its option to extend the Construction Manager at-Risk Miscellaneous (CMR-M) Sheltered Market (SM) Micro Business Enterprise (MBE) Agreement for one year with Llorens Contracting, L.L.C. (Llorens), which holds an M-DCPS M/WBE certificate (Hispanic-American).

Background

On April 9, 2014, the Board commissioned Llorens, as a CMR-M SM MBE firm for projects with construction budgets up to \$200,000 each, for a four-year term, and subsequently authorized a one-year extension and a two-year extension to the firm's Agreement, which expires on April 8, 2021.

To effectively support ongoing, future Capital and General Obligation Bond funded projects, staff recommends that the CMR-M Agreement be extended for one (1) year. The firm has accepted the District's offer to extend their current Agreement under the same fees, terms and conditions, with any prior amendments thereto, at no additional cost to the Board.

The firm was requested to submit updated documentation for review and acceptance by staff. The firm's licenses, insurance and certificates remain in full force and effect. There have been no changes to the firm's principals, management/company structure or location.

Evaluation

M-DCPS' CMR Performance Evaluation (most recent average scores for projects currently underway or completed within the last three years, based on a scale of 1-5, low to high) as of September 30, 2020, for Llorens is 3.15.

That The School Board of Miami-Dade County, Florida, authorize a one-year extension of the Construction Manager at-Risk Sheltered Market, Micro Business Enterprise Agreement under the same fees, terms and conditions as the original Agreement, as amended, for miscellaneous projects with construction budgets up to \$200,000 each, with Llorens Contracting, L.L.C.
