Procurement Management Services, at the request of the Division of Life Skills and the Learn to Swim Program, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract, at firm fixed prices, for electrical installations and related work, for the Learn to Swim Program, which provides swimming services to students in elementary schools and K- 8 Centers at Miami-Dade County Public Schools. This is a term bid which states that the Board may purchase services, as may be needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website, as well as Periscope and DemandStar. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a period of three (3) years, commencing April 21, 2021 through April 20, 2024, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods.

The Goal Setting Committee has assigned an SBE/MBE preference of 3% for this ITB.

Two (2) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract will be awarded to one (1) vendor, which is MWBE certified.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or MWBE certification status of the firm.
