Background:

At its meeting of January 17, 2018 (Agenda Item F-34), the Board commissioned JCI International, Inc. (JCI), as the Construction Management at-Risk (CMR) firm for the renovations project at Arvida Middle School. As part of their pre-construction services, JCI has worked closely with the Project Architect in developing construction documents by providing scheduling, as-built verification, constructability reviews and cost estimating services. This project is for the renovations to portions of the existing facility. This contract provides a Guaranteed Maximum Price (GMP) for construction to the Board.

On December 14, 2020, fifty-three (53) sealed subcontractor bids were received and opened at the offices of JCI International, Inc. The Project Architect and staff from the Office of School Facilities Construction witnessed the bid openings and tabulation process. Negotiations with JCI concluded successfully and the GMP agreed to for this project is \$2,826,877.55, which includes an Owner's Contingency of \$122,500.00. This contract covers all required work and includes subcontracts, materials, contingency, general conditions, bonds, overhead and profit.

The contract provides for compliance with Small Business, Micro Business and Minority Owned Business Utilization Goals. The Office of School Facilities Construction staff reviewed the SBE, MBE and M/WBE certification status of all subcontractors and verified the existence of a Letter of Intent for each, outlining roles and responsibilities.

Small/Micro Business S/MBE Utilization:

A mandatory S/MBE participation goal of 15% for Construction Management and 17.89%

for Construction was established for this project (as determined by the M-DCPS Goal Setting Committee).

Minority/Women Business Enterprise (M/WBE) Utilization:

A mandatory M/WBE participation goal of 7.11%; encompassing African American, Native American and Asian American firms; was established for this project (as determined by the M-DCPS Goal Setting Committee).

Description and Scope

Existing Campus:

Arvida Middle School is located at 10900 S.W. 127 Avenue, Miami, Florida 33186. The facility is bordered on the north by S.W. 108 Street, on the east by S.W. 127 Avenue, on the west by Arvida Park, and on the south by a residential neighborhood. The existing school was built in 1975, with additions constructed afterwards, and is currently comprised of six (6) permanent buildings situated on an approximately 9-acre parcel of land. The facility has a permanent capacity of 1,129 student stations and will remain so upon completion of this Phase.

Project Scope:

The proposed scope of work for this project includes, but is not limited to:

- ❖ Replacement of 11 AHUs, VAVs, ductwork, motorized dampers, CO2 Sensors, Bi-Polar Ionization, drain pans and associated MEP scope
- * Replacement of chillers, pumps, louvers and exhaust fans
- ❖ Backflow Preventer w/ chain link fence and gate
- Exterior and interior painting
- Door Replacement and new hardware
- * Re-grade around basketball courts and provide new basketball standards
- Replace Stage Wood Flooring
- Miscellaneous electrical upgrades
- Miscellaneous fire sprinkler upgrades
