**SUBJECT: AWARD INVITATION TO BID NO. ITB-20-062-EV – BOILER
AND WATER HEATER PURCHASE, REPAIR AND REPLACE**

Procurement Management Services, at the request of Facilities Operations - Maintenance, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract with an approved pool of vendors to direct purchase parts and equipment only, and to establish a contract with an approved pool of vendors to furnish all labor, supervision, equipment, and materials necessary to supply, install, service and/or repair any component of industrial boilers and water heaters at Miami-Dade County Public Schools' facilities. This is a term bid which states that the Board may purchase services, as may be needed, but is not obligated to purchase any guaranteed amount. Awarded vendors will be invited to participate in site scope meetings and the Request for Quotations process. Per this ITB, projects under \$1,000 will be awarded on a rotating basis. This ITB was advertised on the Procurement Management Services website, as well as DemandStar. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a period of three (3) years, commencing February 9, 2022 through February 8, 2025, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods.

The Goal Setting Committee recommended that this solicitation be open with a 5% price preference for SBE/MBE certified firms to be evaluated at the time of the Request for Quotations.

Three (3) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract shall be awarded to three (3) vendors meeting the minimum requirements, of which one (1) is certified.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s).
