Procurement Management Services, at the request of the Office of Alternative Education, released the above-referenced solicitation. The purpose of this Request for Proposals (RFP) is to partner with agencies that will provide educational and wrap-around services which address all critical areas for the education of at-risk students. This RFP was advertised on the Procurement Management Services website, as well as DemandStar. The solicitation was shared with the District’s Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a three (3) year period, commencing March 9, 2022 through March 8, 2025, and may be extended for two (2) additional one (1) year periods, and if needed, an additional ninety (90) days beyond the expiration of the renewal period, at the District’s discretion, pending contract negotiations.

The Goal Setting Committee recommended that this solicitation be open with a 10-point preference for any for-profit SBE/MBE certified firms.

Four (4) vendors responded to this advertised bid. Based on the solicitation criteria, responses in the Q&A session, and the Selection Committee’s final scoring, two (2) vendors are being recommended for award, pending contract negotiations.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s).
