SUBJECT: AWARD INVITATION TO BID NO. ITB-21-019-MV - ESSER FUNDED PROMETHEAN PANELS

Procurement Management Services, at the request of the Office of Instructional Technology, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract, at firm-fixed pricing, to purchase Promethean ActivPanels and their installation for use by Miami-Dade County Public Schools. This is a term bid which states that the Board may purchase quantities as needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website, as well as DemandStar. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a period of two (2) years, commencing May 18, 2022 through May 17, 2024, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for three (3) additional one (1) year periods.

The Goal Setting Committee assigned a mandatory sub-contracting requirement to use a M-DCPS certified non-minority women or African-American installation firm to install all 2,500 Promethean Panels.

Nine (9) vendors responded to this advertised bid. Based on the criteria listed in the solicitation, the contract will be awarded to one (1) vendor and a certified African-American subcontractor, thus meeting the requirement established by the Goal Setting Committee.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the subcontracted firm.
