Mr. Jean Claude Saint Phard immigrated to Florida at the age of sixteen. He is a product of Miami-Dade County Public Schools (M-DCPS), graduating from Miami Jackson Senior High School in 1983. His teaching career began in 2000 as a Culinary Arts instructor at Lindsey Hopkins Technical College. During his eleven-year tenure at Lindsey Hopkins, Mr. Saint Phard earned his certification in Mathematics, Exceptional Student Education and Educational Leadership. In 2010, he was promoted to Assistant Principal and served in that capacity at Charles Drew Middle Community School and Brownsville Middle School. Mr. Saint Phard has been an Assistant Principal at George T. Baker Aviation Technical College since 2015.

While working at Baker Aviation, Mr. Saint Phard attained his Federal Aviation Administration (FAA) mechanic license. As a licensed Aircraft Maintenance Technician, he provided group and individualized tutoring, refresher courses and test taking techniques to dual-enrolled and post-secondary students, as they prepared for their FAA licensure examination. Significant learning gains are evident through the increased pass rate of the FAA tests. Through Mr. Saint Phard's efforts, these students can obtain their licenses and at the same time, gain employment in the aviation industry.

Mr. Saint Phard credits the adult and vocational education program of Miami-Dade County Public Schools (MDCPS) as the catalyst to his success as an educator and administrator. He attributes his colleagues and administrators who sacrificed their time and expertise to provide him with the skills and training necessary, to put him in a position to succeed, culminating with being recognized as the Miami-Dade County Public Schools 2022, Assistant Principal of the Year.
