SUBJECT: REQUEST AUTHORIZATION TO WAIVE PROCESS FOR COMPETITIVE PURCHASE OF SERVICES PROVIDED BY AMERICORPS GRANT

At the Board meeting of August 18, 2021, the Board voted to require a competitive bidding process for purchases of goods and services exceeding \$50,000 single and \$100,000 aggregate, when utilizing funding provided by The American Rescue Plan Act of 2021 and related COVID-19 federal stimulus funds.

In FY 2021, Americorps received federal funds from the Corporation for National and Community Service (CNCS). The mission of CNCS is to improve lives, strengthen communities, and foster civic engagement through service and volunteering. AmeriCorps' federal grants are awarded to eligible organizations proposing to engage AmeriCorps' members in evidence-based or evidence-informed interventions/practices to strengthen communities. Americorps selected Up2Us Inc. (UP2US) through a competitive process, where benchmarks and performance metrics were established. Therefore, it is considered impractical to undergo another competitive process inasmuch as UP2US is the sole provider of the sports portion of the CNCS Focus Area of Education award, employing UP2US Coaches. The District seeks to enter into a contract with UP2US for these services. The program will subsidize the cost of teacher salaries that are recruited to work with this program. The remaining funds are budgeted to be spent utilizing ESSER dollars.

The District will benefit from the services as follows:

- Cost sharing for each position (to M-DCPS)
 - Full-Time Positions-1700 hours @ a cost of \$10,000.00 per position
 - Half-Time Positions-900 hours @ a cost of \$5,000.00 per position
 - Quarter-Time Positions-450 hours @ a cost of \$3,000.00 per position
- Remaining costs including Benefits and Health Insurance will be paid by UP2US via AmeriCorps
- Assist with addressing staff shortages for afterschool care, academic, and enrichment programs
- Opportunity to provide students with more enrichment activities
- Volunteers receive training in mentoring strategies and Sports-Based YouthDevelopment
- The organization will actively recruit and train volunteer coaches
- Volunteers will adhere to District guidelines for clearance
