SUBJECT: UPDATE ON BOARD-RELATED SECURITY MEASURES

At the School Board Meeting of October 20, 2021, the Board approved Good Cause item H-17, *Security and Safety Provisions, Protocols, and Procedures for School Board Related Events and Activities*, proffered by School Board Vice Chair Dr. Steve Gallon, III, and supported by all Board Members at the dais. Good Cause item H-17 directed the Superintendent of Schools to enact a series of Board actions outlined in sections 1,2,3, and 4 of the item. Section 3 of the item concerned individual discussions with Board Members regarding issues of safety and security at School Board events and related activities. Section 4 of the item concerned the development of security procedures and guidelines regarding School Board events and related activities, including but not limited to enhanced security, transport, and threat assessments.

On January 12, 2022, the Board received a brief follow-up memorandum concerning Good Cause item H-17. Pursuant to this memorandum, information regarding the implementation of this Board action was to be discussed with the Board at a confidential security-session scheduled for January 25, 2022. On May 16, 2022, the Board received an additional follow-up memorandum advising the Board about safety measures being enacted pursuant to Board action in Good Cause item H-17.

This Board item seeks to direct the Superintendent of Schools to provide the Board with an updated report and oral presentation on the implementation of School Board action in Good Cause item H-17, specifically sections 3 and 4 of the item, as informed to the Board in the May 16, 2022, memorandum.
