The purpose of this request is to obtain approval of a supplemental award on the following term contract, inasmuch as the estimated requirements, previously awarded by the Board, will be exceeded for the 2022-23 FY. This Request for Proposals (RFP) requires that professional development services be provided for the following three groups of participants: 1) Catholic schools represented by the Archdiocese of Miami; 2) Jewish schools represented by the Center for the Advancement of Jewish Education; and 3) Private schools not affiliated with the above (approximately 15 private, independent schools based on 2017- 2018 totals). This one-time supplement is required to amend the 2022-23 FY award to \$1,036,714 for each additional one-year extension period, to be able to provide equitable professional learning services to all non-public schools' participants, as required by Title II, Part A, Supporting Effective Instruction Grant, and amend the total contract award to \$1,036,714 for each additional one-year extension period.
