SUBJECT: REQUEST AUTHORIZATION TO WAIVE PROCESS FOR COMPETITIVE PURCHASE

LINK TO STRATEGIC PLAN: EFFECTIVE AND SUSTAINABLE OPERATIONAL PRACTICES

At the Board meeting of August 18, 2021, the Board voted to require a competitive bidding process for purchases of goods and services exceeding \$50,000 single and \$100,000 aggregate, when utilizing funding provided by The American Rescue Plan Act of 2021 and related COVID-19 federal stimulus funds. It is considered impractical to undergo a competitive process for the following:

Agency	Amount	Funding Period	Purpose
UP2US INC funded by Americorps	\$1,100,000	October 19, 2022 - August 14, 2024	The program will subsidize the cost of teacher salaries that are recruited to work with this program. The remaining funds are budgeted to be spent utilizing ESSER dollars. UP2US is the sole provider of the sports portion of the CNCS Focus Area of Education award, employing UP2US Coaches.
ACT, Inc.	\$1,073,000	October 19, 2022 – June 30, 2022	To provide several opportunities for students to take college entrance exams that also meet concordant requirements for graduation during the school day. The ACT will be administered twice. ACT, Inc. is the sole source and owner of the ACT® test, test items, scoring algorithms, reporting and research services and the sole source for all related materials.
PSAT via COLLEGE BOARD, INC.	\$72,000	October 19, 2022 – June 30, 2022	To provide several opportunities for students to take college entrance exams that also meet concordant requirements for graduation during the school day. The CollegeBoard is the sole administrator for the assessment and related materials.
