**CHARTER SCHOOL CONTRACT AMENDMENTS**

Section 1002.33(7)(d), F.S., indicates that a charter may be modified during its initial term or any renewal term upon the recommendation of the sponsor or the charter school’s governing board and the approval of both parties to the agreement.

Policy 9800 requires that the Superintendent convene the Contract Review Committee (CRC) to meet publicly and negotiate any substantive amendments to charter school contracts for presentation to the School Board for their final consideration.

Pursuant to the law and School Board Policy 9800, *Charter Schools*, two (2) amended charter school contracts are being presented for consideration in this item, as contained in Table 1. Additional details for these contracts may be found in Attachment A. The contracts can be accessed through the links provided on page 2.
