**SUBJECT: MIAMI-DADE COUNTY SCHOOL BOARD v. YEWANDE SMITH**  
**DOAH Case No. 21-2670**

On August 18, 2021, the School Board took action to demote Respondent, Yewande for just cause, including but not limited to failure to complete assigned tasks, non-performance and deficient performance concerning her job duties and responsibilities; violation of departmental procedures and School Board Policies 4210, *Standards of Ethical Conduct*; and 4210.01, *Code of Ethics* in accordance with §§ 1001.32(2), 1012.22(1)(f), and 447.209, Fla. Stat.

The Administrative Law Judge issued his Recommended Order on August 19, 2022. The Judge recommended that the School Board enter a Final Order upholding the demotion of Respondent.

Exceptions to the Recommended Order were timely filed by the Respondent. The Exceptions, along with the Recommended Order, the Superintendent's Response to Respondent's Exceptions and a complete record of the case, will be forwarded to the School Board under separate cover. The Superintendent's Response seeks to adopt the Recommended Order of the ALJ as the Final Order of the School Board.
