POWER LAWN EQUIPMENT (SHELTERED MARKET FOR
CERTIFIED FIRMS)**

Procurement Management Services, at the request of Plant Operations, released the above-referenced solicitation. The purpose of this Invitation to Bid (ITB) is to establish a contract with qualified vendors at firm unit prices, for the purchase and delivery of high powered, industrial/commercial power lawn equipment and pressure washers to be delivered on an as needed basis to various locations throughout Miami-Dade County Public Schools. This is a term bid which states that the Board may purchase quantities as needed, but is not obligated to purchase any guaranteed amount. This ITB was advertised on the Procurement Management Services website and DemandStar. This contract impacts all locations and/or schools across the District which breaks down to the annual amount of \$3.85 per student, school, and employee based on the annual contract amount of \$1,000,000. The solicitation was shared with the District's Office of Economic Opportunity (OEO) for additional community outreach.

The initial term of the bid shall be for a period of three (3) years, commencing April 19, 2023 through April 18, 2026, and may, by mutual agreement between The School Board of Miami-Dade County, Florida, and the successful bidders, be extended for two (2) additional one (1) year periods.

Pursuant to School Board Policy 6320.02, the Goal Setting Committee recommended that this solicitation be sheltered for firms certified by the M-DCPS Office of Economic Opportunity. In addition, a 5% price preference was assigned for M-DCPS certified African American and Non-Minority Women owned firms.

Five (5) vendors responded to this advertised bid, of which two submitted "no bid" documentation and two (2) were deemed non-responsive. Based on the criteria listed in the solicitation, the contract will be awarded to one (1) vendor, which is certified.

M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s).

In Fiscal Year 2021-2022, the District spent \$118,079 on power lawn equipment.
