The purpose of this request is to obtain approval of a supplemental award on the following term contract, inasmuch as the estimated requirements, previously awarded by the Board, will be exceeded before the contract extension term(s) expires. Due to an increase in student referrals to support student's mental health needs, this supplement is required to provide comprehensive community based mental health services to support the District's Mental Health Assistance Plan. This Request for Proposals (RFP) allows the District to procure services, however, the awarded vendors are encouraged to maximize third (3<sup>rd</sup>) party health insurance benefits and/or Medicaid, where appropriate. This RFP includes mental health services in the following six areas: 1) Mental health screenings and assessments, 2) Individual and group counseling, 3) Family counseling, 4) Substance abuse intervention, 5) Parent/teacher consultation, and 6) Case management. This contract impacts all District students, which breaks down to an annual amount of \$8.75 per student based on the annual contract amount of \$2,900,000.
