Procurement Management Services, at the request of the Office of School Leadership and Performance, released the above-referenced solicitation. The purpose of this Invitation to Negotiate (ITN) is to provide a pool of qualified providers for school-site principals to choose from for offering On-Site Before and/or After School Childcare and/or On-Site Community Enrichment Program services for Elementary Schools, K-8 Centers, Middle Schools, 6-12 Centers, High Schools and Centers for Special Education, for Miami-Dade County Public Schools. This ITN was advertised on the Procurement Management Services website and DemandStar. The solicitation was shared with the District's Office of Education & Economic Access for additional community outreach.

The initial term of the bid shall be for a five (5) year period, through an Affiliating Agreement to be approved annually, with one (1) five (5) year option to renew and if needed, an additional ninety (90) days beyond the expiration of the renewal period, at the District's discretion, pending contract negotiations.

Pursuant to School Board Policy 6320.02, the Goal Setting Committee assigned no goal to this solicitation.

Twenty (21) vendors responded to this advertised bid. M-DCPS OEO staff verified the Small, Micro, Veteran and/or M/WBE certification status of the firm(s). Based on the criteria listed in the solicitation and the Selection Committee's recommendation, the Selection Committee voted to enter into contracts with thirteen (14) firms for before and after school childcare services and thirteen (13) firms for community enrichment program services.
