**SUBJECT: REQUEST AUTHORIZATION TO ACCEPT GRANT AWARDS/DONATIONS FROM MULTIPLE FUNDING SOURCES AND ENTER INTO CONTRACTUAL SERVICE AGREEMENTS WITH THE AGENCIES PRESCRIBED IN THE GRANT**

Authorization is requested to accept three grant awards and two donations in accordance with Budget Summary Forms, Attachments 1.a. through 1.c., for the approximate total of \$3,079,255, as follows:

STOP School Violence Program Competitive Solicitation	United States Department of Justice	\$1,000,000	October 1, 2024 – September 30, 2027	Competitive	To improve school climate and expand mental health support interventions for students at 30 middle schools.
Radio Community Service Grant	Corporation for Public Broadcasting	\$883,832  This allocation is an increase of \$148,265 or 20.16% from the 2023-2025 allocation.	October 1, 2024 – September 30, 2026	Allocation	To support the day-to-day operations of WLRN Radio.
Television Community Service Grant	Corporation for Public Broadcasting	\$670,423  This allocation is a decrease of \$389 or less than 1% from the 2023-2025 allocation.	October 1, 2024 – September 30, 2026	Allocation	To support the day-to-day operations of WLRN Television.

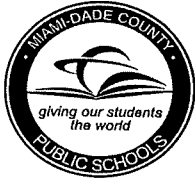

Hasbro Toy Distribution	Global Empowerment Mission (GEM)	In-kind support valued at \$350,000	August 18, 2024 – January 31, 2025	Donation	To distribute toys to elementary school students for the holidays.

**RECOMMENDED:** That The School Board of Miami-Dade County, Florida, authorize the Superintendent to:

1. accept three grant awards and two donations from:
  - a. United States Department of Justice for funding under the STOP School Violence Program Competitive Solicitation, in the approximate amount of \$1,000,000, for the grant period of October 1, 2024, through September 30, 2027;
  - b. Corporation for Public Broadcasting for funding under the Radio Community Service Grant, in the approximate amount of \$883,832, for the grant period of October 1, 2024, through September 30, 2026;
  - c. Corporation for Public Broadcasting for funding under the Television Community Service Grant, in the approximate amount of \$670,423, for the grant period of October 1, 2024, through September 30, 2026;
  - d. Pinecrest Elementary School Parent Teacher Association for funding under the Walking Track, in the approximate amount of \$175,000, for the grant period of July 1, 2024, through June 30, 2025; and
  - e. Global Empowerment Mission (GEM) for in-kind support under Hasbro Toy Distribution, in the approximate amount of \$350,000, for the grant period of August 18, 2024, through January 31, 2025.
2. enter into contractual service agreements with the agencies prescribed in the grant, with whom the School Board must contract, pursuant to Board Policy 6320 – Purchase Approval and Competitive; Bidding Process Requirements;

- a. Rachel's Challenge, in the approximate amount of \$618,000, in the support of the STOP School Violence Program Competitive Solicitation.
3. extend these programs and contractual agreements and authorize the acceptance of additional funding as provided by official notification from the granting agency in order to complete the goals of the program;
4. retain funds from the grant in an amount not to exceed the annually negotiated indirect cost rate, as allowed and approved by the FLDOE;
5. direct Financial Services to establish appropriations in the amount approved or as amended by the granting agency; such appropriations to be reported periodically to the Board;
6. authorize travel out-of-state as required by the grant parameters; and
7. eliminate any grant-funded position upon cessation of the grant funds and place the impacted employee(s) on the Personnel Action Listing of Instructional and Non-Instructional Appointments, Reassignments, Leaves and Separations for the relevant period.

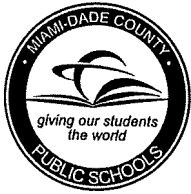
