**SUBJECT: EXPLORE FEASIBILITY OF A WEARABLE PANIC BUTTON FOR SCHOOL STAFF TO ENHANCE OUR CURRENT MOBILE ALERT SYSTEM**

The safety and security of our schools is of paramount importance to Miami-Dade County Public Schools (M-DCPS). This has been and must always be a priority for the School Board and District. Having our own police department, a mobile panic alert system, school mapping, ensuring our schools are fortified with a single point of entry, and the use of Fortify FL are some of the many ways we are committed to protecting our students, employees and all stakeholders. As a district, it is our responsibility to not only provide these safety measures, but to continuously evaluate and review them regularly as well as constantly look for ways to enhance them. This commitment is evident in the items that Board members have actively proffered regarding safety and security. The School Board previously approved some items pertaining to safety and security, such as the following:

In accordance with Section (s.) [1006.07\(4\)](#), Florida Statutes (F.S.), M-DCPS uses a mobile panic alert system capable of connecting diverse emergency service technologies to ensure real-time coordination between multiple first responder agencies. Board Policy 8410 Emergency Management, Preparedness, and Response requires that the Superintendent in conjunction with Emergency Management and School Safety Specialist, develop the District's Emergency Operations Plan (EOP), which includes an active assailant response plan and a mobile panic alert system, also known as "Alyssa's Alert." This alert system was developed in consultation with the county 911 authority and local emergency management office to ensure that the system integrates with local public safety answering point (PSAP) infrastructure to transmit calls and mobile activations. The District's mobile panic alert system must include mobile devices placed throughout each school campus. The system we currently use has a mobile panic alert set up on desktop computers and staff members' individual mobile cell phones that immediately notifies school staff and law enforcement.

Additional layers of technology exist that could enhance our current alert system. The use of a wearable panic button has been used in other school districts and proved to be a lifesaving factor in the Apalachee High School Shooting of 2024. A wearable panic system provides a way for staff to immediately alert school staff, law enforcement, and other first responders even if they don't have immediate access to their phone or desktop computer. These systems can function everywhere without the need for Wi-Fi or cellular service. Other features are available with the wearable panic button such as activating a full audio and visual campus-wide

notification system, allowing everyone on campus to be made aware that there is a current threat.

This board item seeks to request that the Superintendent of Schools explore the feasibility of enhancing our current mobile panic alert system by adding an additional layer of a wearable panic button for school staff members.

This item has been reviewed and approved by the Office of the General Counsel as to form and legal sufficiency.
