As per the Head Start Program Performance Standards (HSPPS) Part 1301 – Governance, a Head Start agency must establish and maintain a formal structure for program governance that includes a governing body. Governing bodies have a legal and fiscal responsibility to administer and oversee the agency’s Head Start and Early Head Start (HS/EHS) programs.

As per HSPPS Part 1301 – Governance, and the Interlocal Grant Agreement with Miami-Dade County (i.e., Grantee), The School Board of Miami-Dade County, Florida, as governing body, is responsible for the review and approval of selected items related to the operation of the HS/EHS programs in the district. These items include:
