CANCER AWARENESS MONTH AT ALL MIAMI DADE COUNTY

The month of September is nationally recognized as Childhood Cancer Awareness Month, a time dedicated to raising awareness about pediatric cancer, honoring the courage of children and families affected, and supporting efforts for research, treatment, and care.

Childhood cancer is the leading cause of disease-related death in children in the United States. Approximately 15,000 children and adolescents are diagnosed with cancer in the US. About 1 in 285 children will be diagnosed with cancer before the age of 20. The most common childhood cancers include leukemias, brain and central nervous system tumors, and lymphomas. Despite progress in treatments, 1 in 5 children diagnosed with cancer in the U.S. do not survive, and many survivors experience long-term physical, cognitive, and emotional effects.

Every year during the month of September, community organizations throughout Miami-Dade County, such as Live Like Bella, Nicklaus Children's Hospital, The Children's Cancer Fund, Sofia's Hope, and the Sebastian Strong Foundation come together to fight and spread awareness of childhood cancer. Childhood Cancer Month provides the opportunity to spotlight the need for research funding and strong support systems for families navigating this horrible disease.

This board item requests that the Superintendent of Schools, in collaboration with the Office of Community Engagement, partner with local organizations such as, but not limited to, Live Like Bella, Nicklaus Children's Hospital, The Children's Cancer Fund, Sofia's Hope, and Sebastian Strong Foundation to raise awareness of Childhood Cancer.

**ACTION PROPOSED BY

That The School Board of Miami-Dade County, Florida, requests that the Superintendent of Schools to:

1. Recognize September 2025 as Childhood Cancer Awareness Month in all Miami Dade County Public Schools; and
2. Authorize the Superintendent of Schools, in collaboration with the Office of Community Engagement, to engage with local organizations or entities with a mission to spread awareness of childhood cancer, such as, but not limited to, Live Like Bella, Nicklaus Children's Hospital, The Children's Cancer Fund, Sofia's Hope, and Sebastian Strong Foundation, to raise awareness of childhood cancer and support and honor these children and their families.
