On November 14, 2024, the Miami-Dade Transportation Planning Organization (TPO) Governing Board unanimously adopted a motion to promote educational opportunities and exchanges with The School Board of Miami-Dade County, Florida. Miami-Dade County Public Schools has a long-established partnership with the Miami-Dade TPO dedicated to enhancing pedestrian safety for students. Building upon the success of this partnership, the Miami-Dade TPO collaborated with Dr. Contessa S. Bryant, Arts Principal, at the New World School of the Arts (NWSA) and Mr. Ray Parris faculty member to engage students in developing a transportation mascot designed to promote bicycle and pedestrian safety among all age groups.

NWSA is Florida's premier center of excellence in the visual and performing arts and has been named a National School of Excellence under the U.S. Department of Education's Blue Ribbon School Program. The NWSA Digital Imaging/3D Studies/Entrepreneurial class under the leadership of Dr. Bryant, Arts Principal, and teacher Mr. Parris, introduces students to digital and 3D design through hands-on projects and real-world collaborations, where students develop artistic, technical, and entrepreneurial skills that prepare them to create and present innovative visual work.

Three groups of NWSA students from the ninth grade Digital Imaging/3D Studies/Entrepreneurial class were identified to compete for the creation of the Miami-Dade TPO mascot. Throughout the contest process, students engaged in real world experience as they designed their figures with input from Miami-Dade TPO staff and then pitched their final products to a panel of judges at the Miami-Dade TPO office. After judging the mascots, it was Mobility Guardian who took the win with Mobility Maven and Mobility Maverick chosen as Mobility Guardian's friends.
