The financial statements of the Foundation for New Education Initiatives, Inc., DBA Miami-Dade County Public Schools Foundation, Inc., (the "Foundation") for the year ended June 30, 2025, were audited by the external audit firm of Verdeja and Alvarez, Certified Public Accountants and Advisors. The Foundation's annual audit is required by State Board of Education Rule 6A-1.0013, pursuant to Florida Statute 1.001.453, and School Board Policy 9215.

In the independent auditor's report, the external auditor concluded that, in their opinion, "...the financial statements...present fairly, in all material respects, the financial position of the Foundation as of June 30, 2025, and the changes in net assets, cash flows and functional expenses for the year then ended in accordance with accounting principles generally accepted in the United States of America." This language constitutes an unmodified opinion, which is the strongest opinion that can be assigned to a financial statement audit.

As of June 30, 2025, the Foundation's financials reported total net assets of approximately \$2.1 million, which represents an increase from the prior year of approximately \$164,000 or close to 7.8 percent. In addition, total revenues reported at June 30, 2025, were approximately \$5.1 million, of which 22 percent was generated from local grant funds.

Total program services expenditures (intended to enhance students' educational and cultural experiences) amounted to approximately \$4.4 million, or 93 percent of total expenditures, while expenditures for supporting services (including general/administrative and fundraising) were approximately \$333,000, or 7 percent of total expenditures.
