SUBJECT: COMMISSIONING OF LIVS ASSOCIATES AS SPECIAL PROJECTS CONSULTANT (SPC)-ARCHITECTURAL SERVICES

Staff has completed the selection process for Special Projects Consultant (SPC) architectural services discipline.

Thirty (30) firms applied and five (5) firms were interviewed by the A/E Service Committee for SPC-architectural services. Of these five (5) firms, the firm of LIVS Associates was selected.

Negotiations with LIVS Associates have been successfully completed.

The negotiated agreement includes the following provisions for basic services:

A submittal fee of \$500.00 will be paid for each project that requires submission to the Office of Educational Facilities (OEF).

- 2. The agreement is for miscellaneous architectural projects with an initial estimated construction cost of \$200,000 or less. Projects that exceed this limit after the project has been initiated shall be negotiated on an individual basis.
- 3. The SPC will maintain at least a \$1,000,000 Professional Liability Insurance policy, with a deductible of \$25,000 per claim. Since a \$250,000 coverage with a \$15,000 deductible is required, staff is recommending that the Board waives this requirement for this project and accept the firm's insurance coverage.

- 4. The term is for a two (2) year period commencing November 17, 1999 and expiring November 16, 2001.
- 5. The agreement provides for cancellation by the Board with or without cause, upon sixty (60) days written notice to SPC. The SPC may terminate this agreement, only with cause, upon sixty (60) days written notice to the Board.
- 6. The provisional multiplier for hourly compensation is limited to 2.45 for extra work.

The Principals/Owners for LIVS Associates are Osvaldo Landera, Paul Ingelmo, Hector S. Veragara and Carlos A. Alvarez.

RECOMMENDED:

That The School Board of Miami-Dade County, Florida commission the firm of LIVS Associates to provide Special Projects Consultant (SPC) services primarily architectural in nature, for the Board, during a period of two (2) years commencing November 17, 1999 through November 16, 2001.
