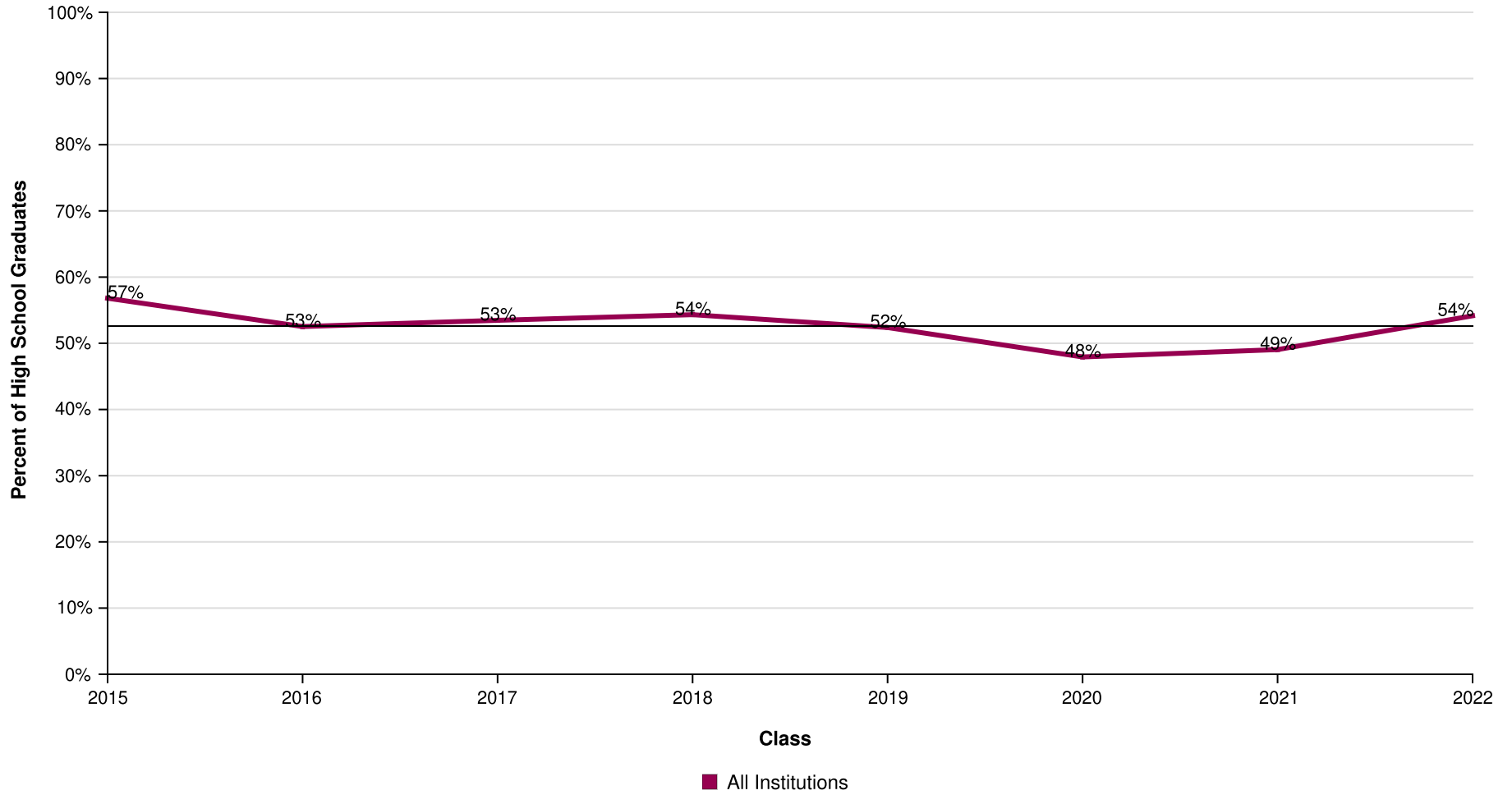

Percent of Students Enrolled in College the Fall Immediately After High School

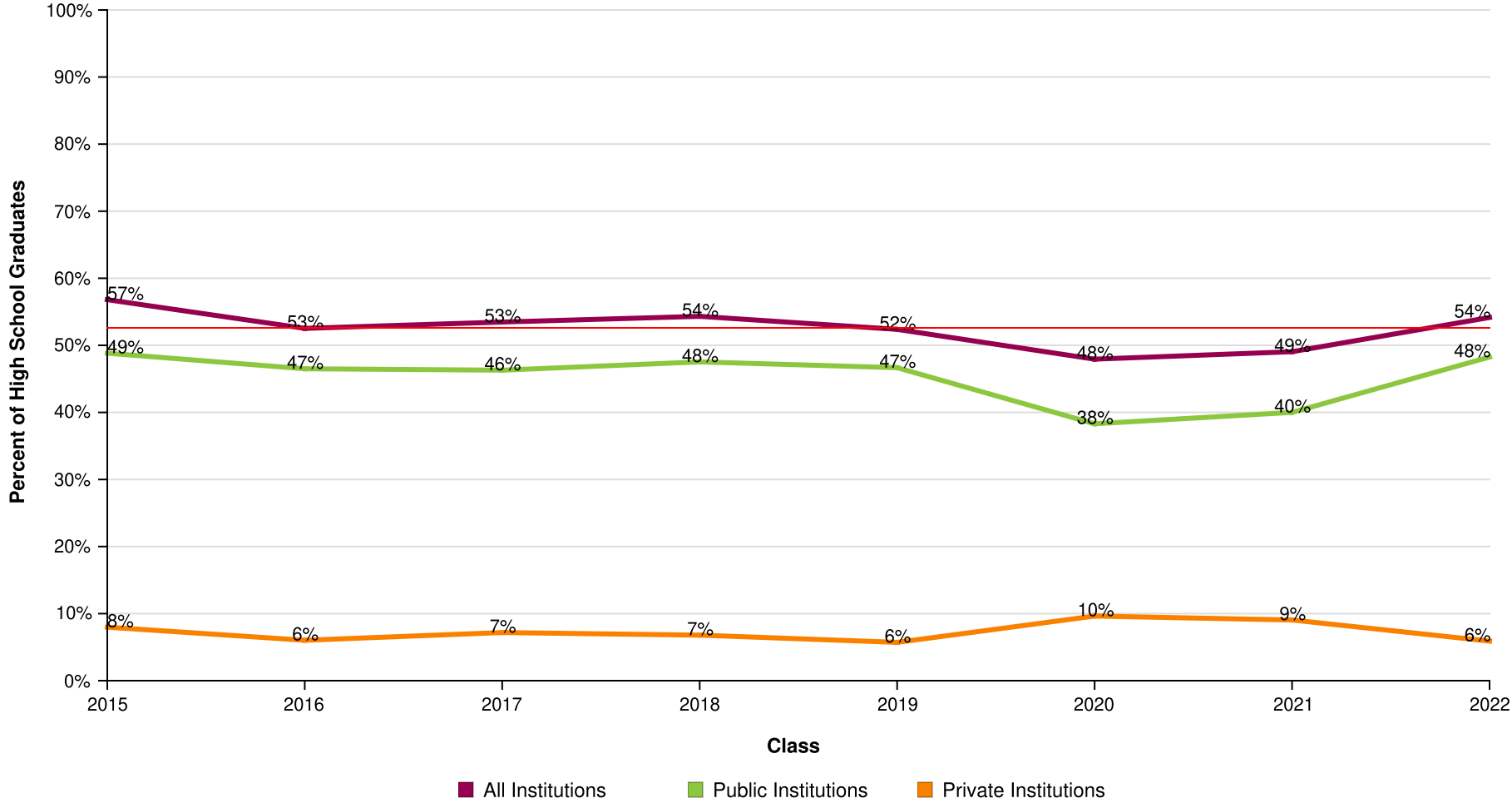

Percent of Students Enrolled in College the Fall Immediately After High School by Institutional Type

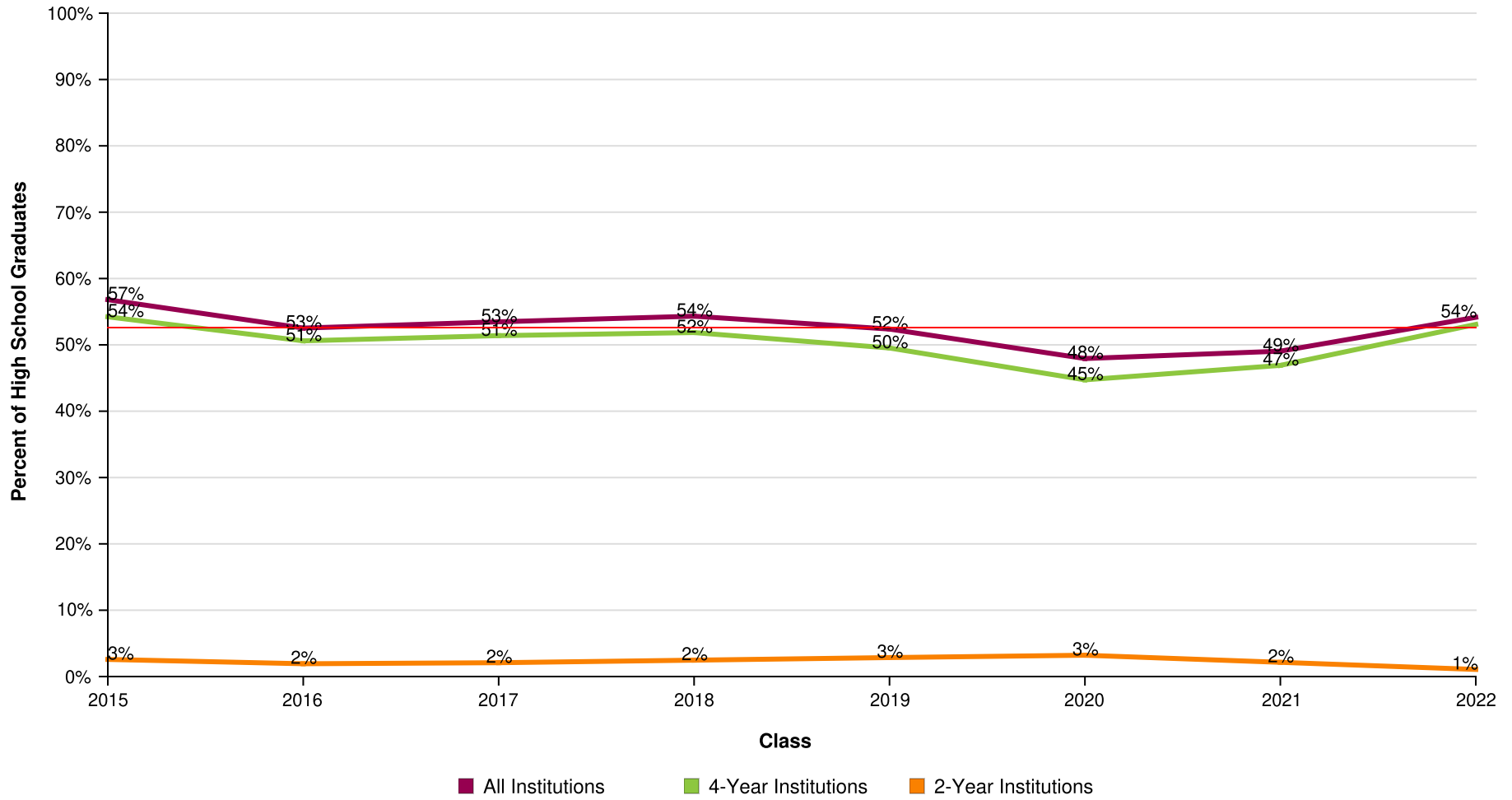

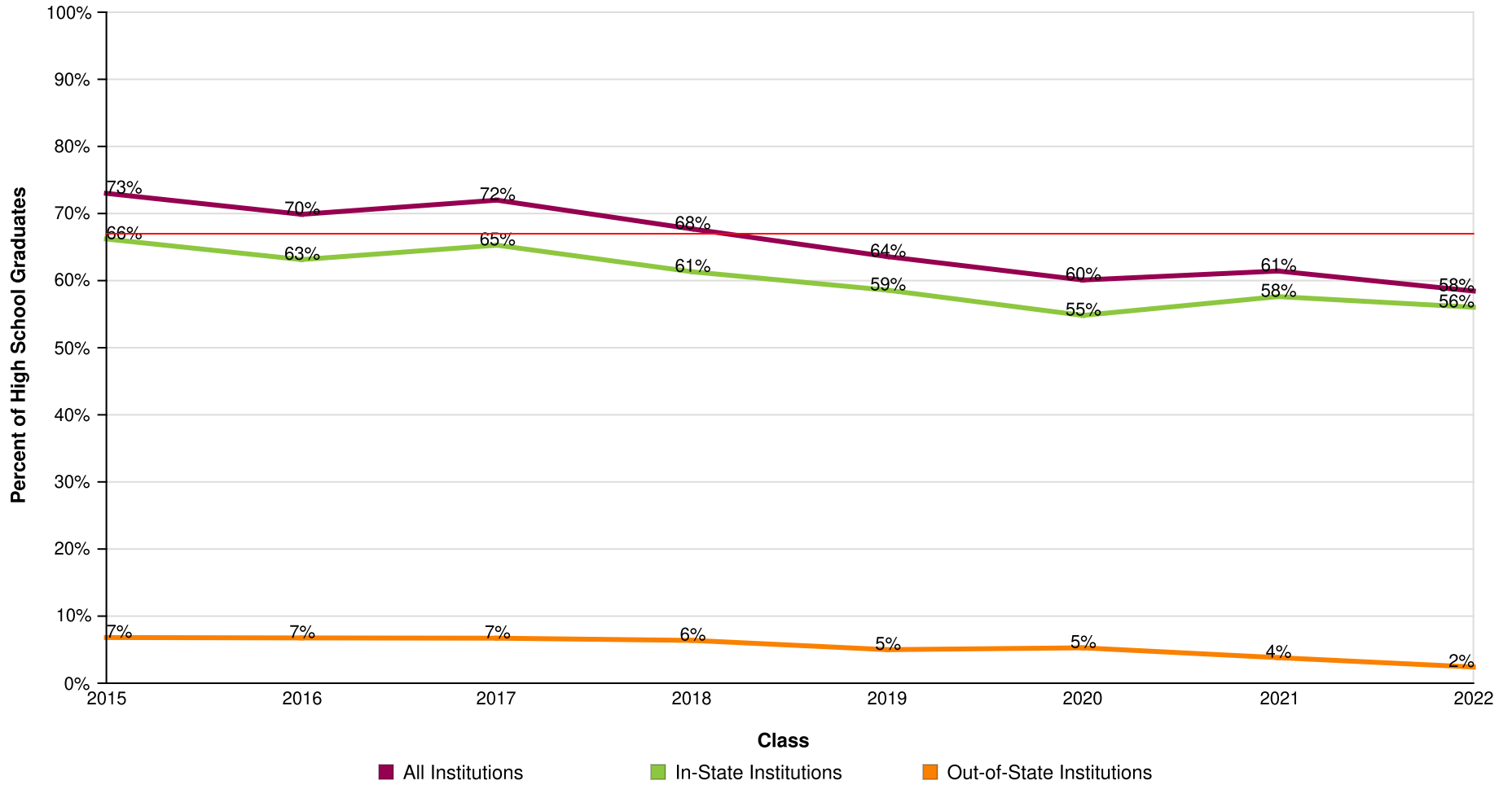

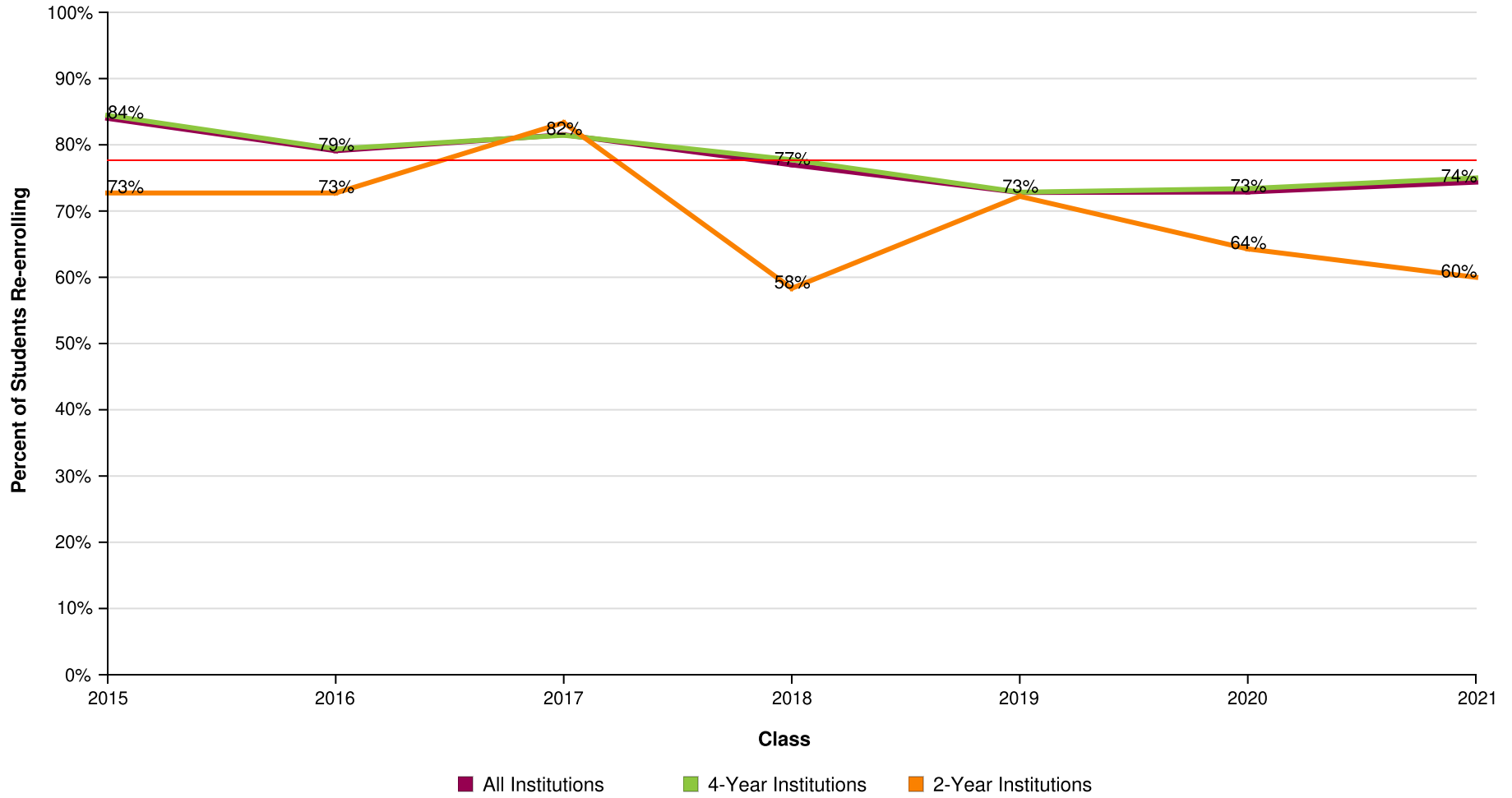

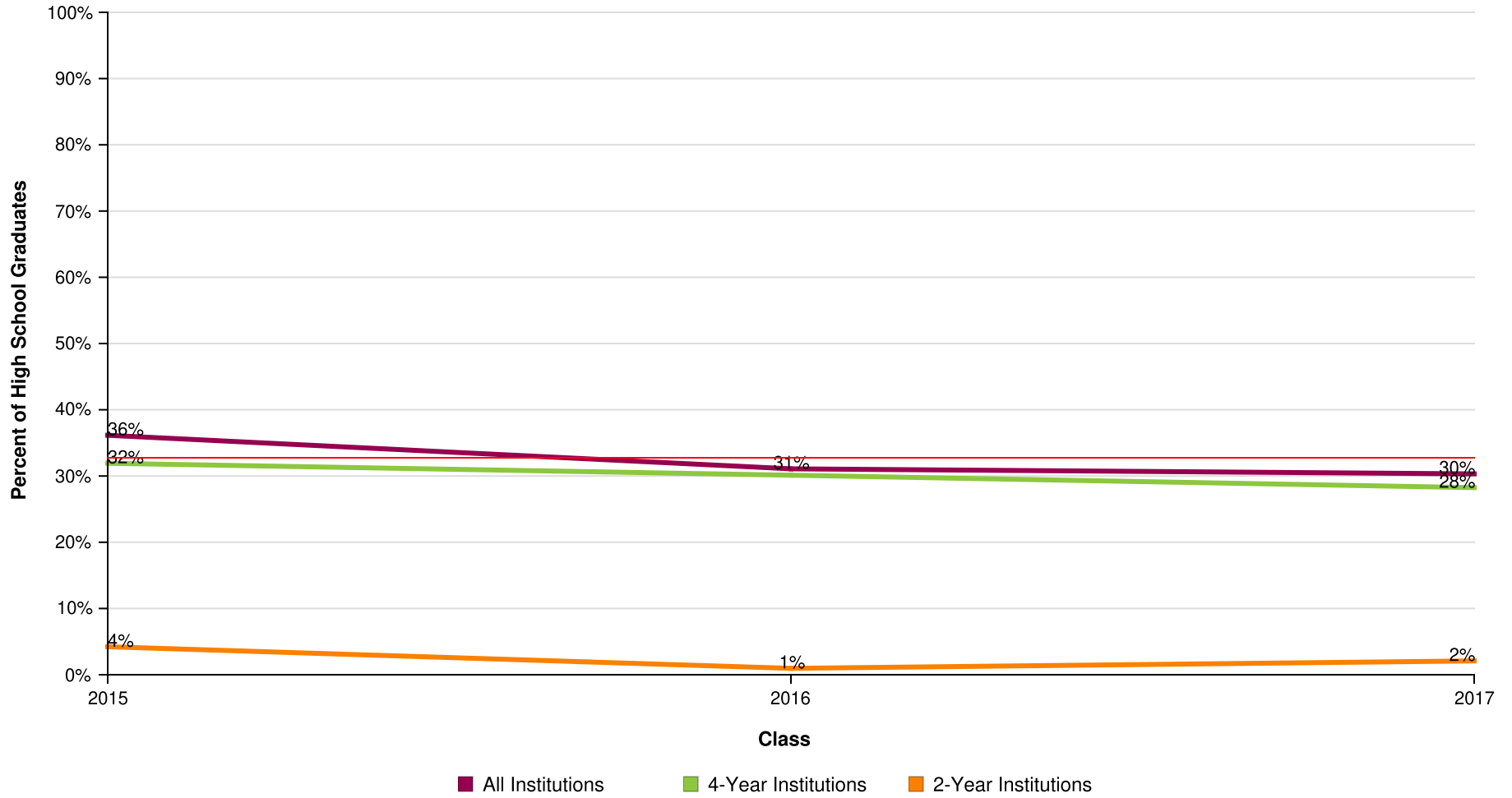

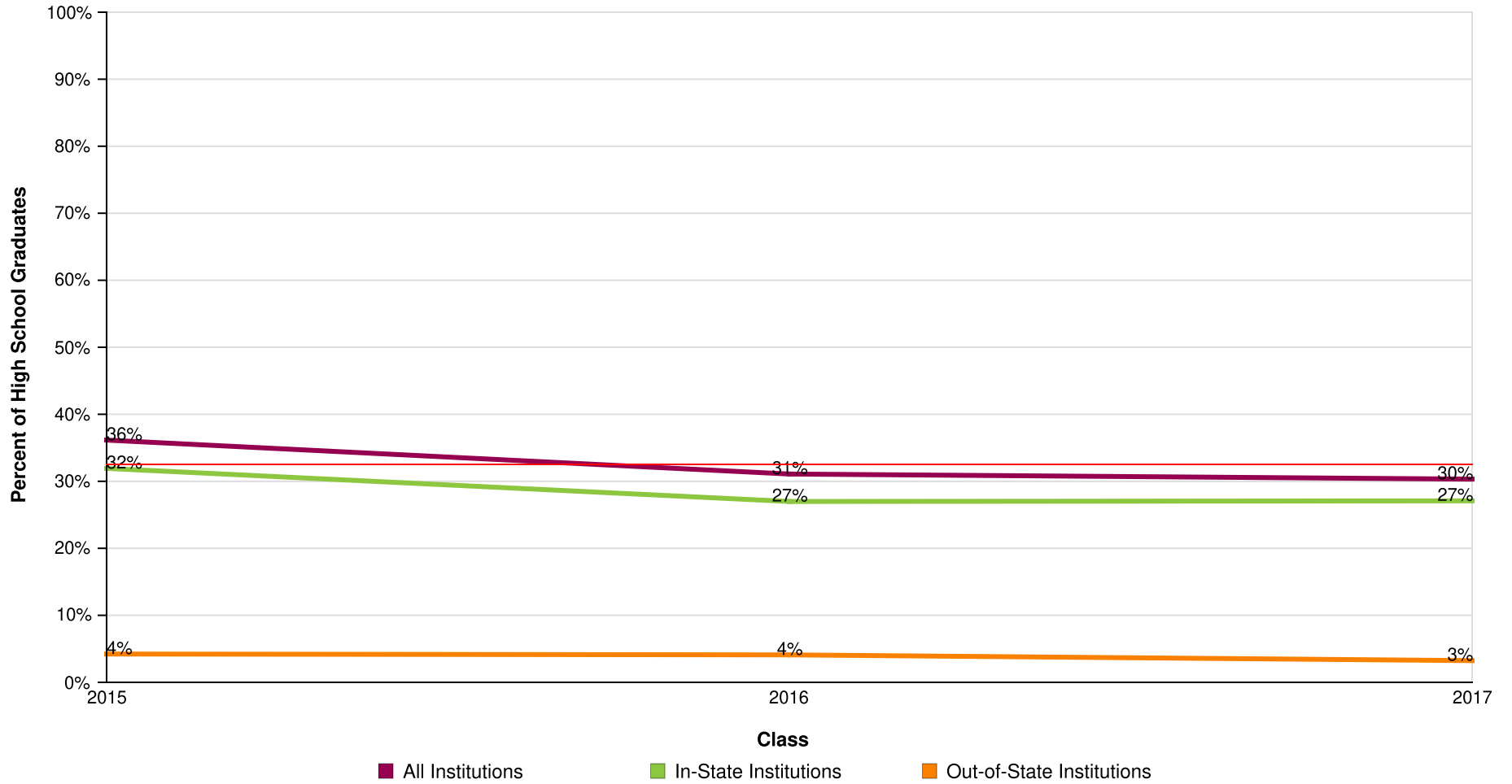

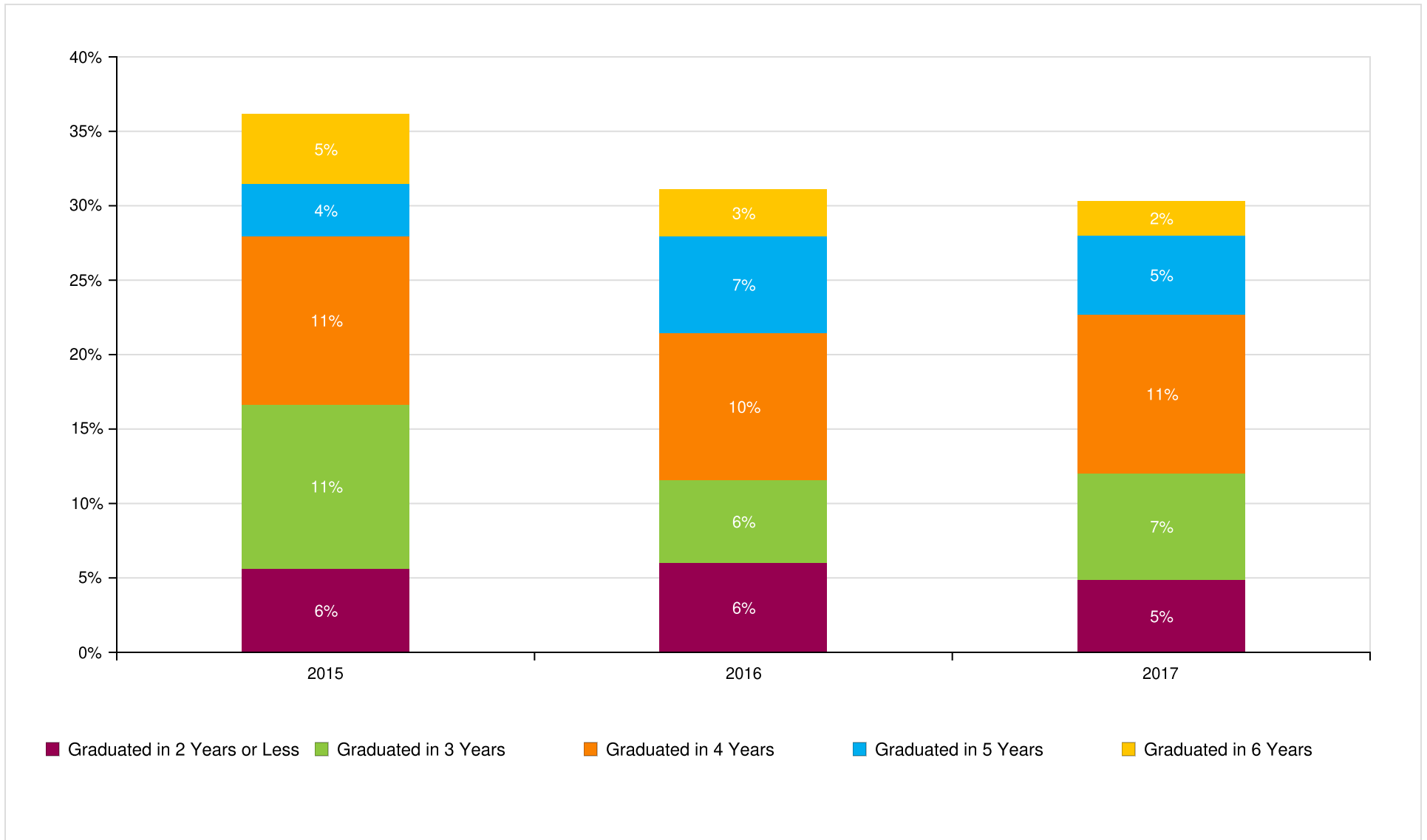

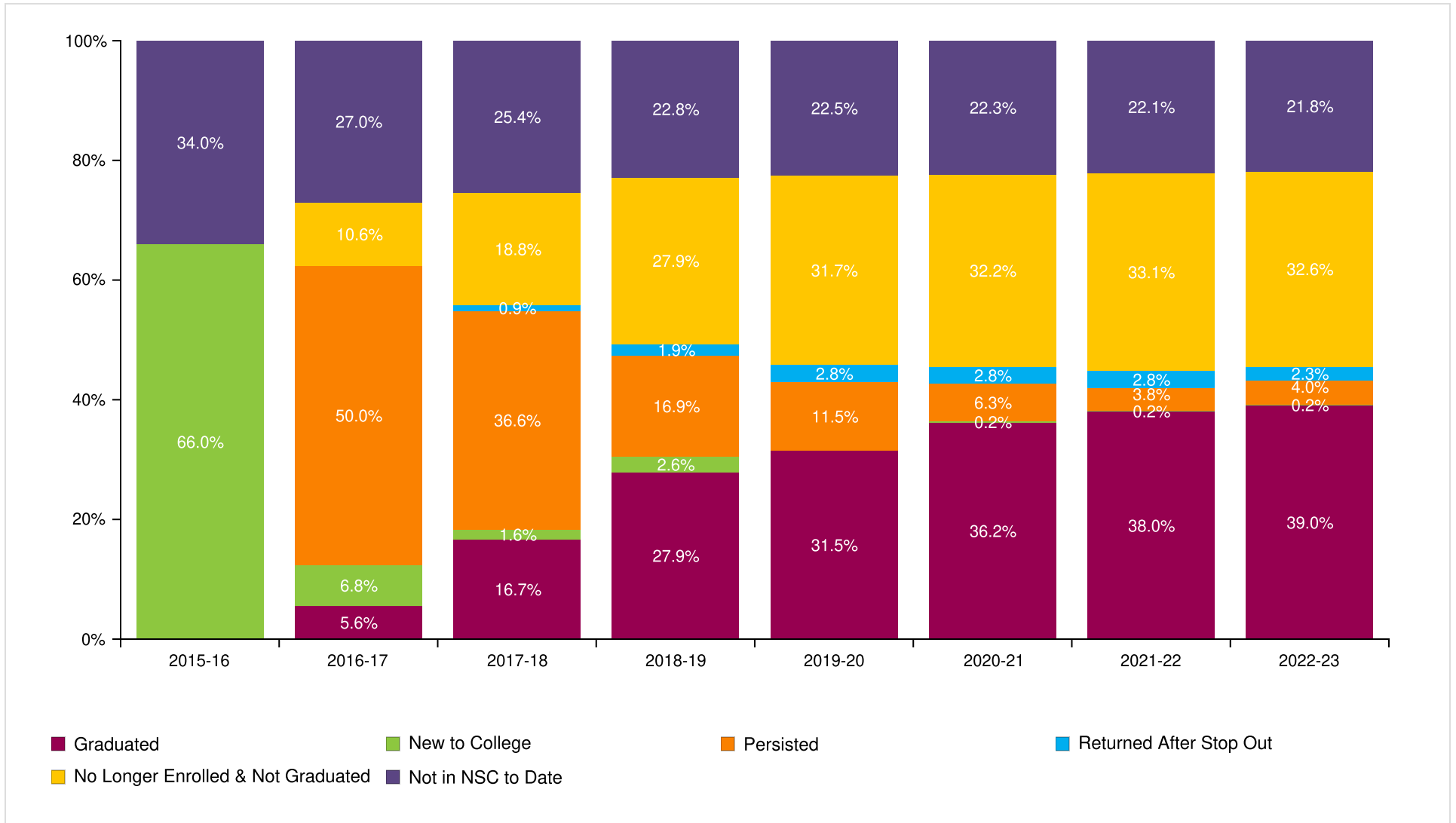

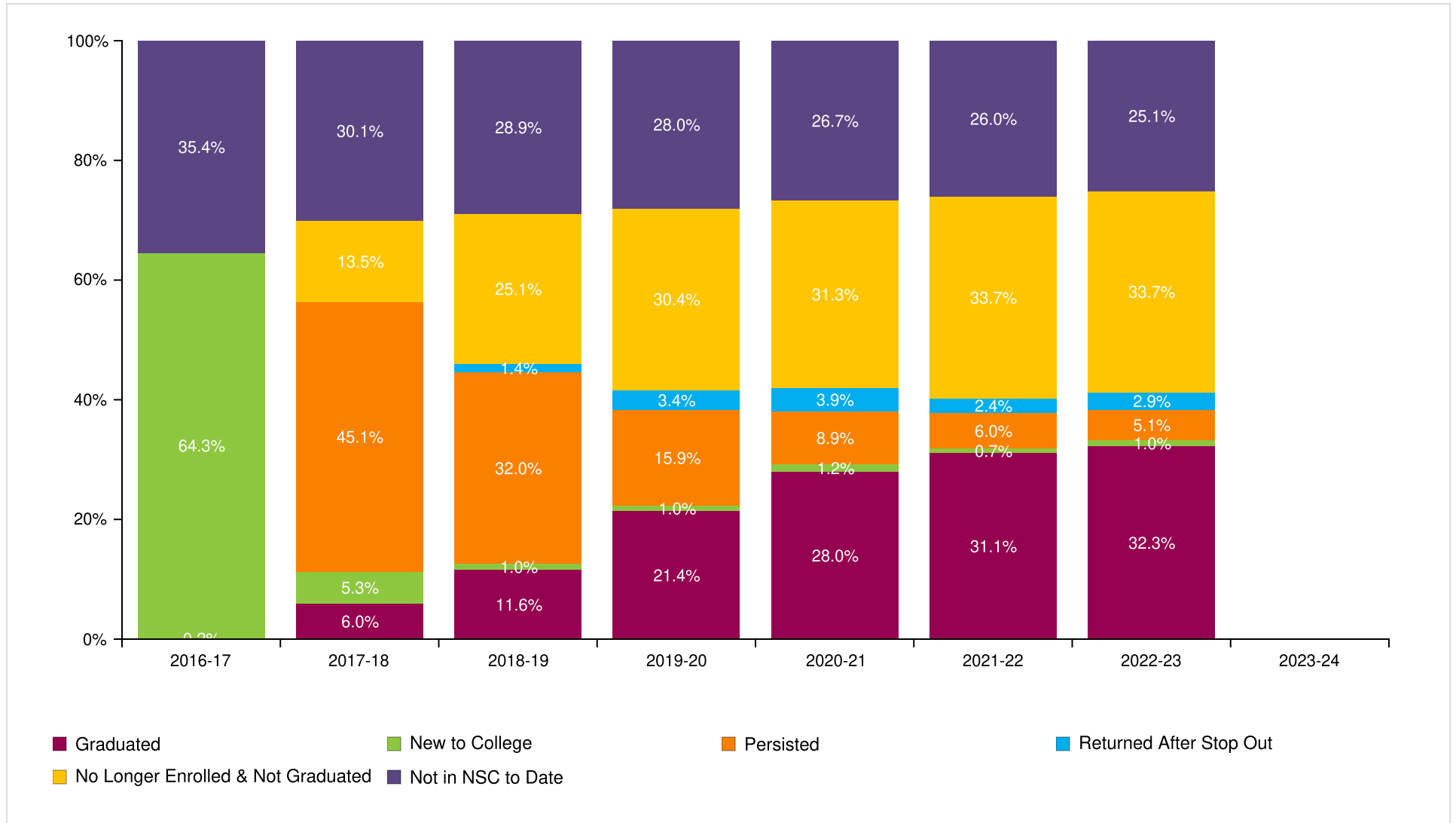

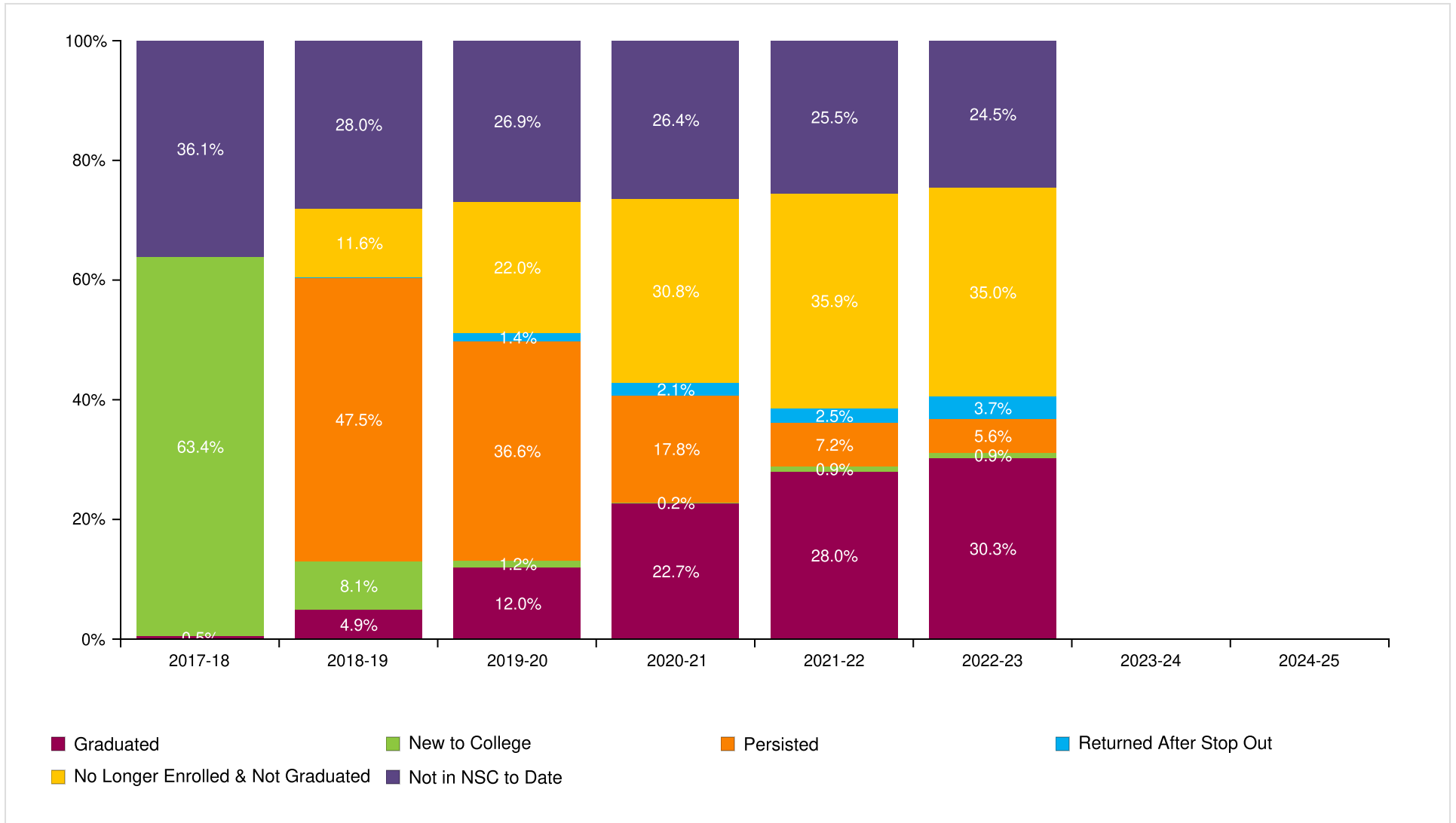

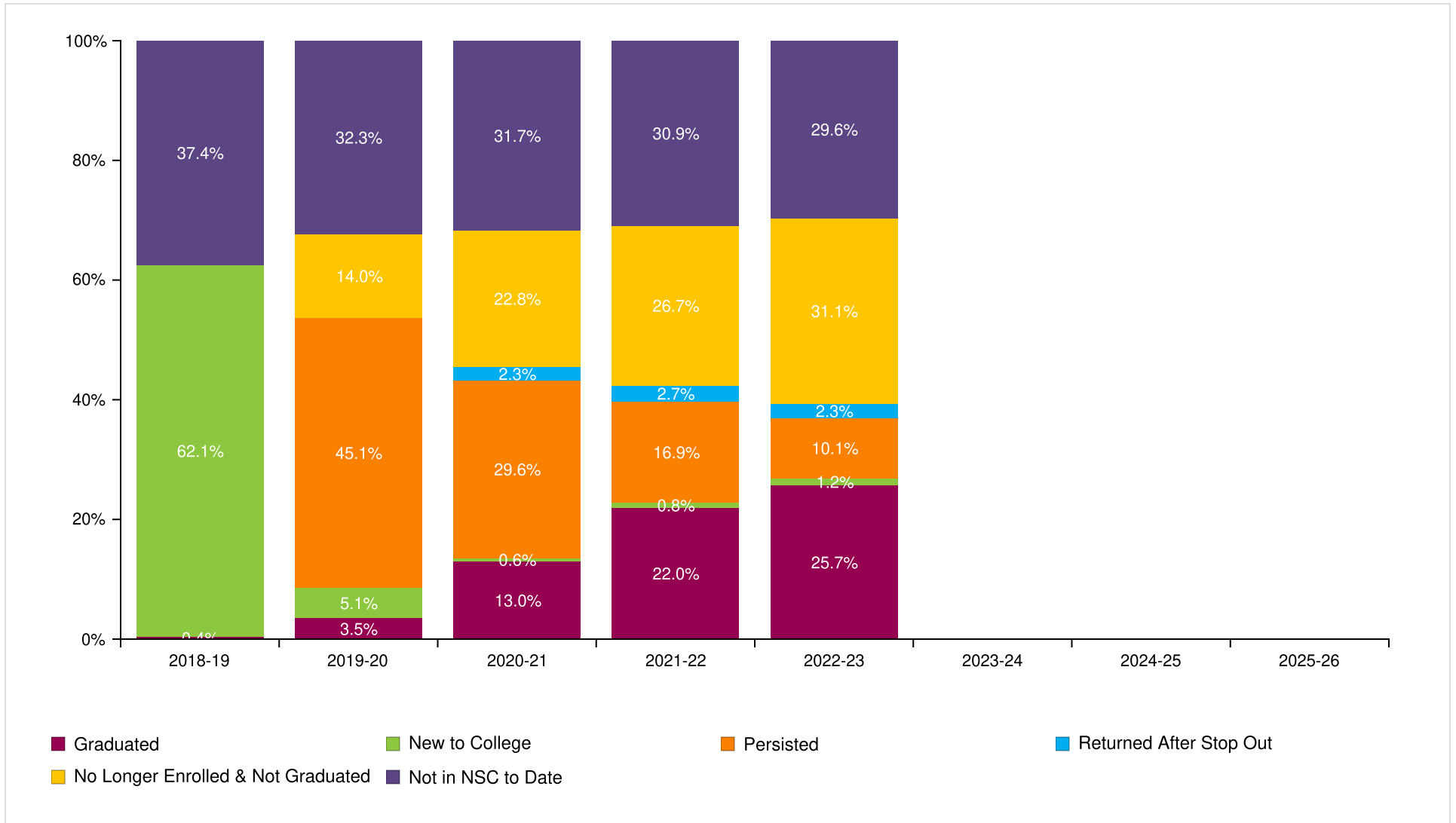

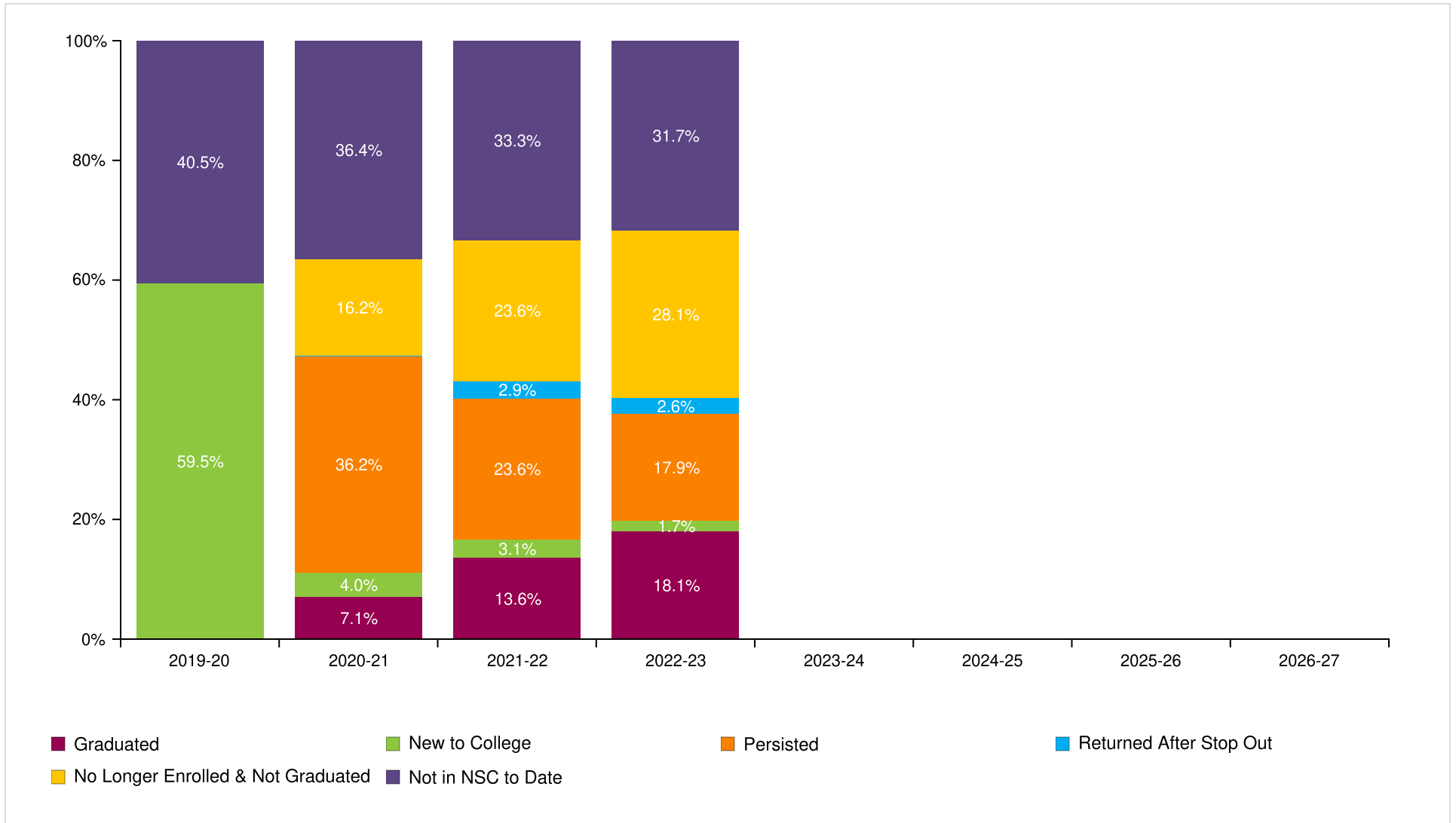

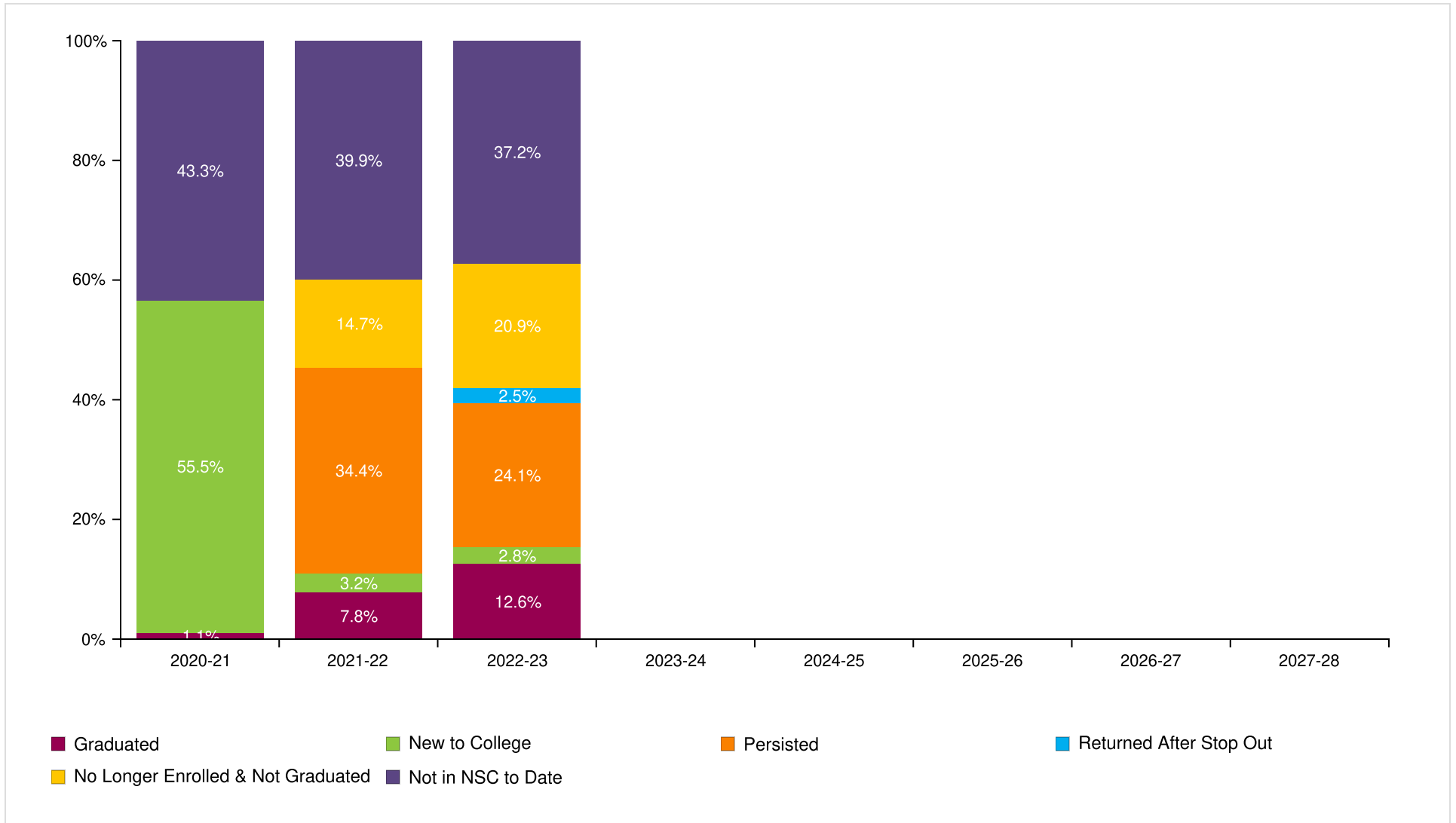

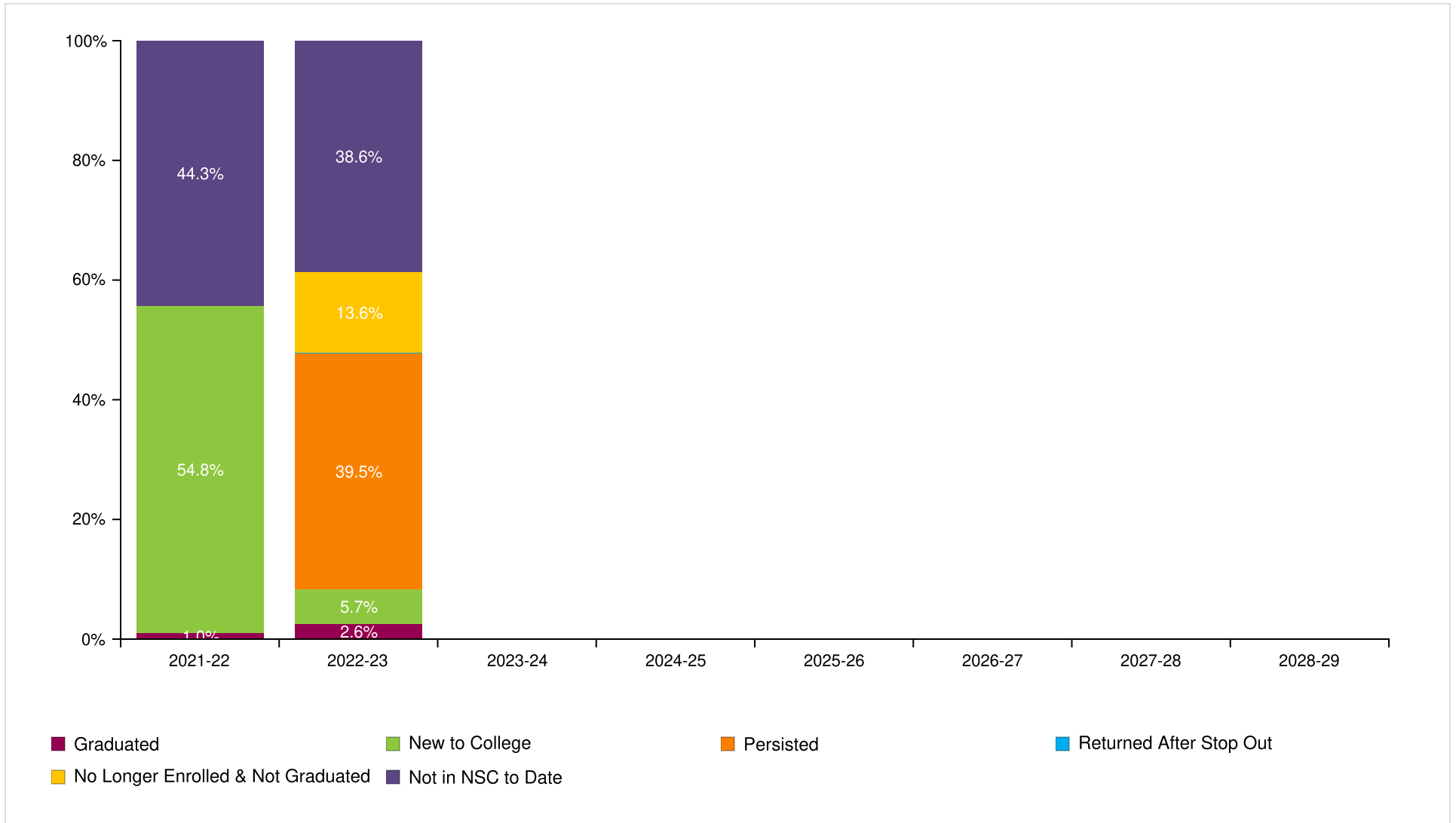

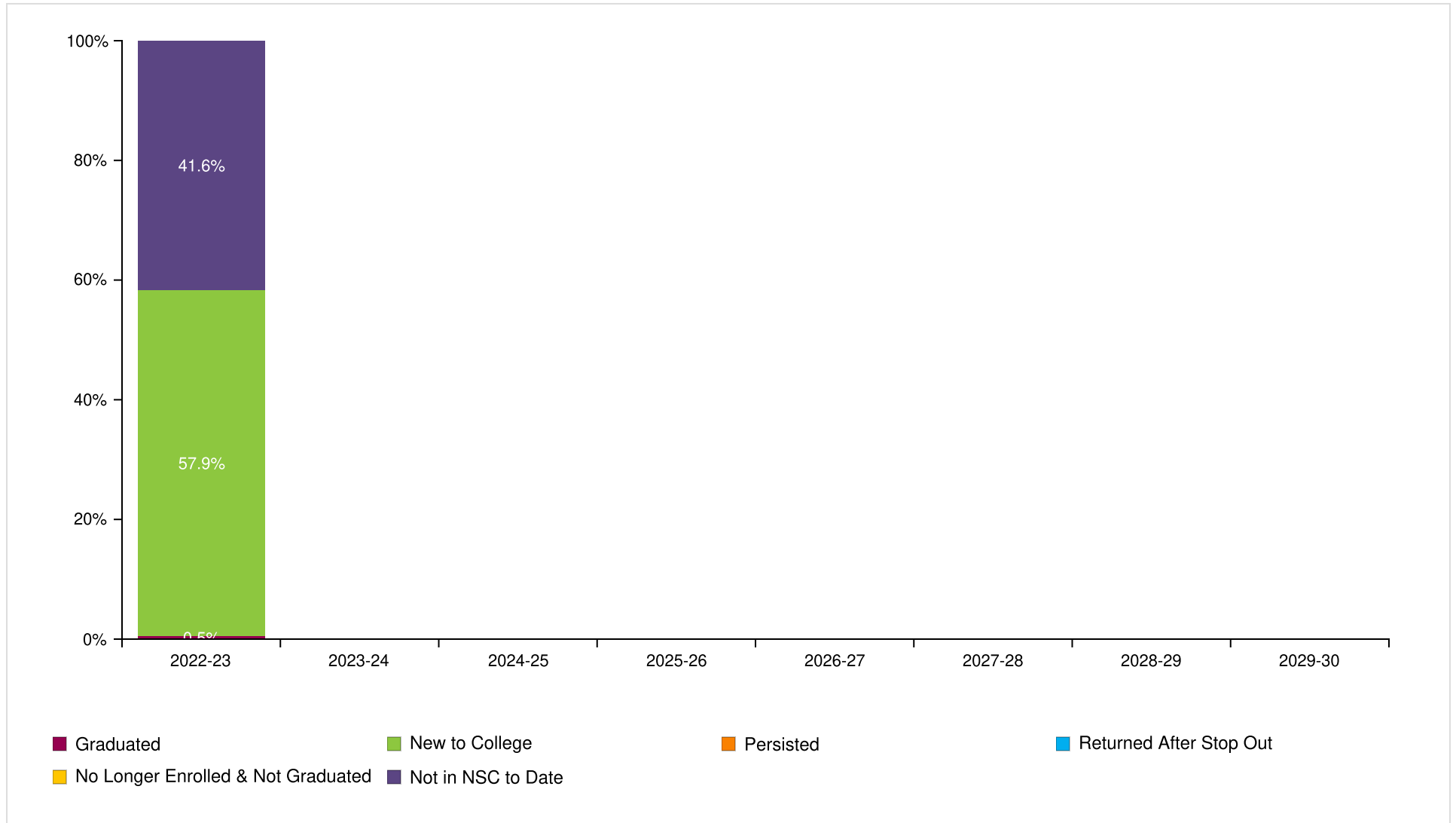
