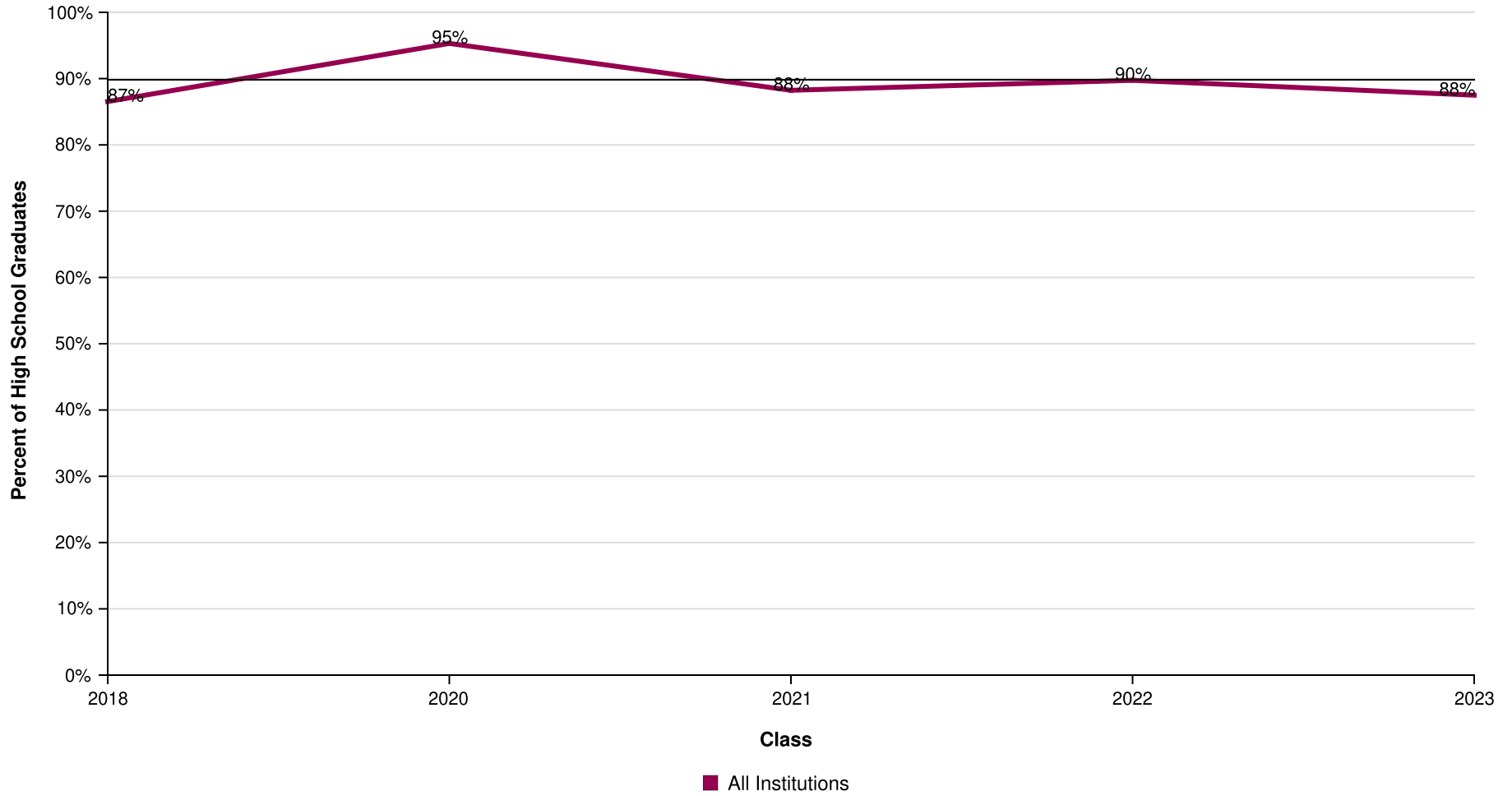

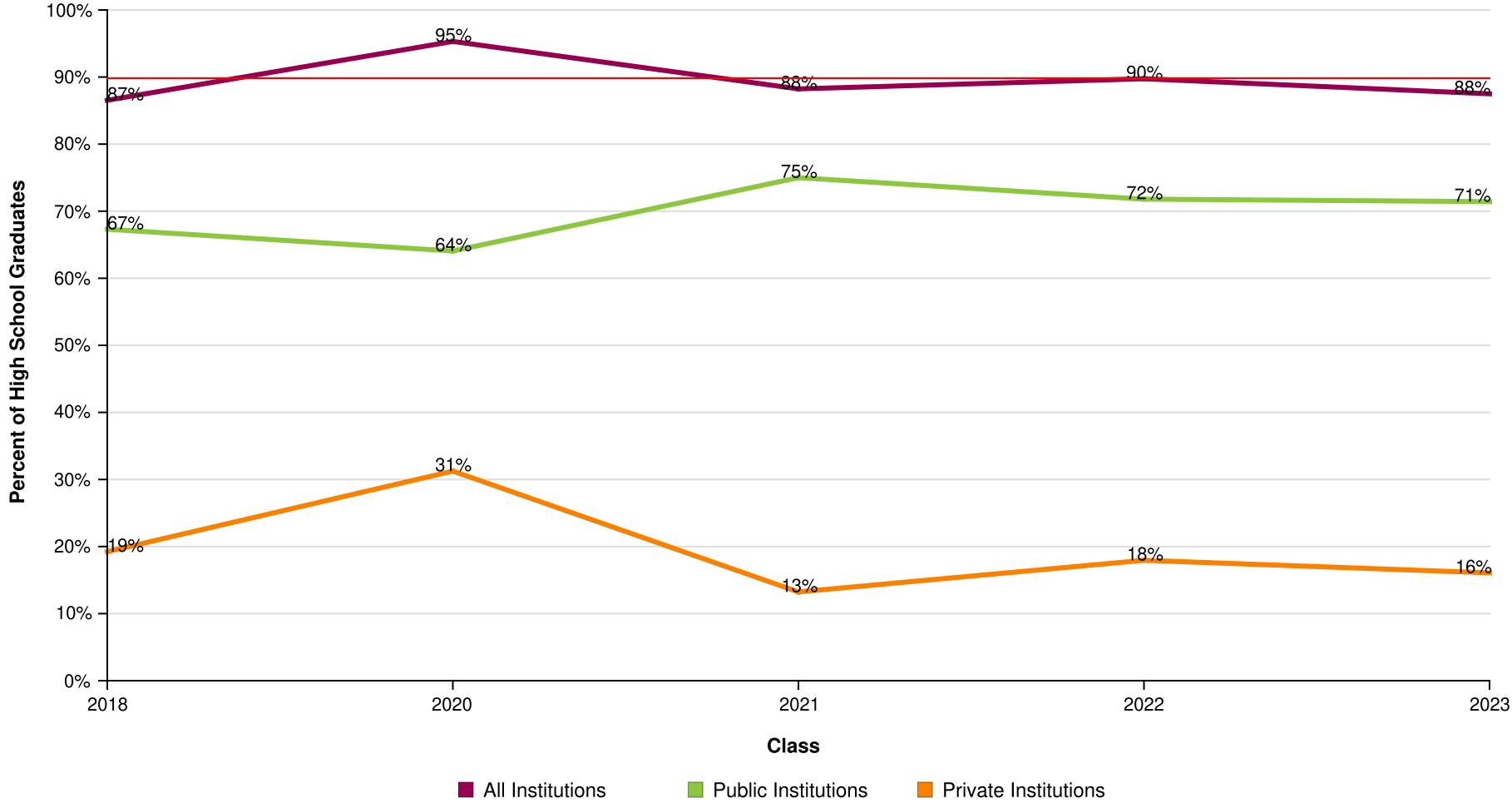

Percent of Students Enrolled in College the Fall Immediately After High School by Institutional Type

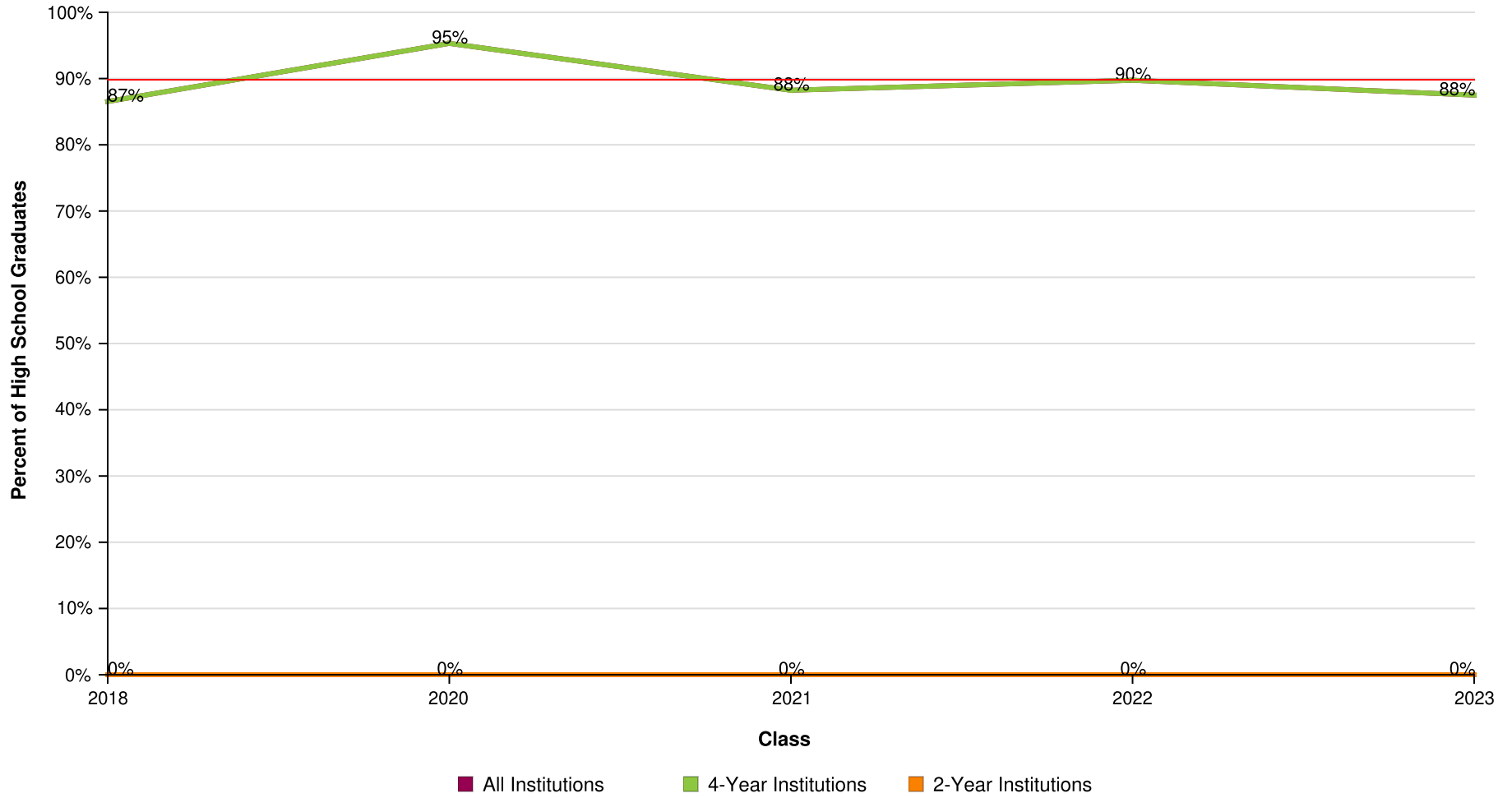

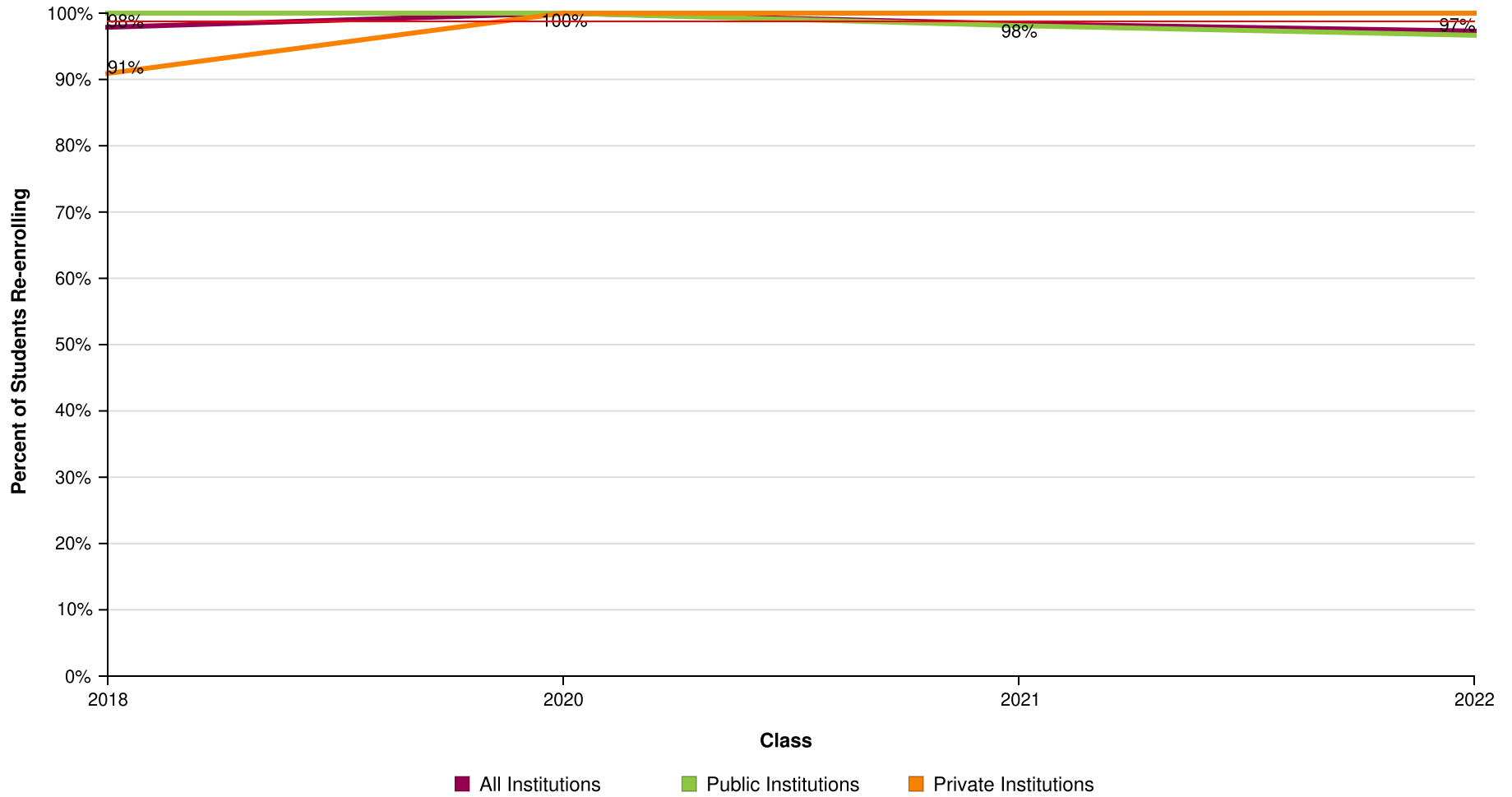

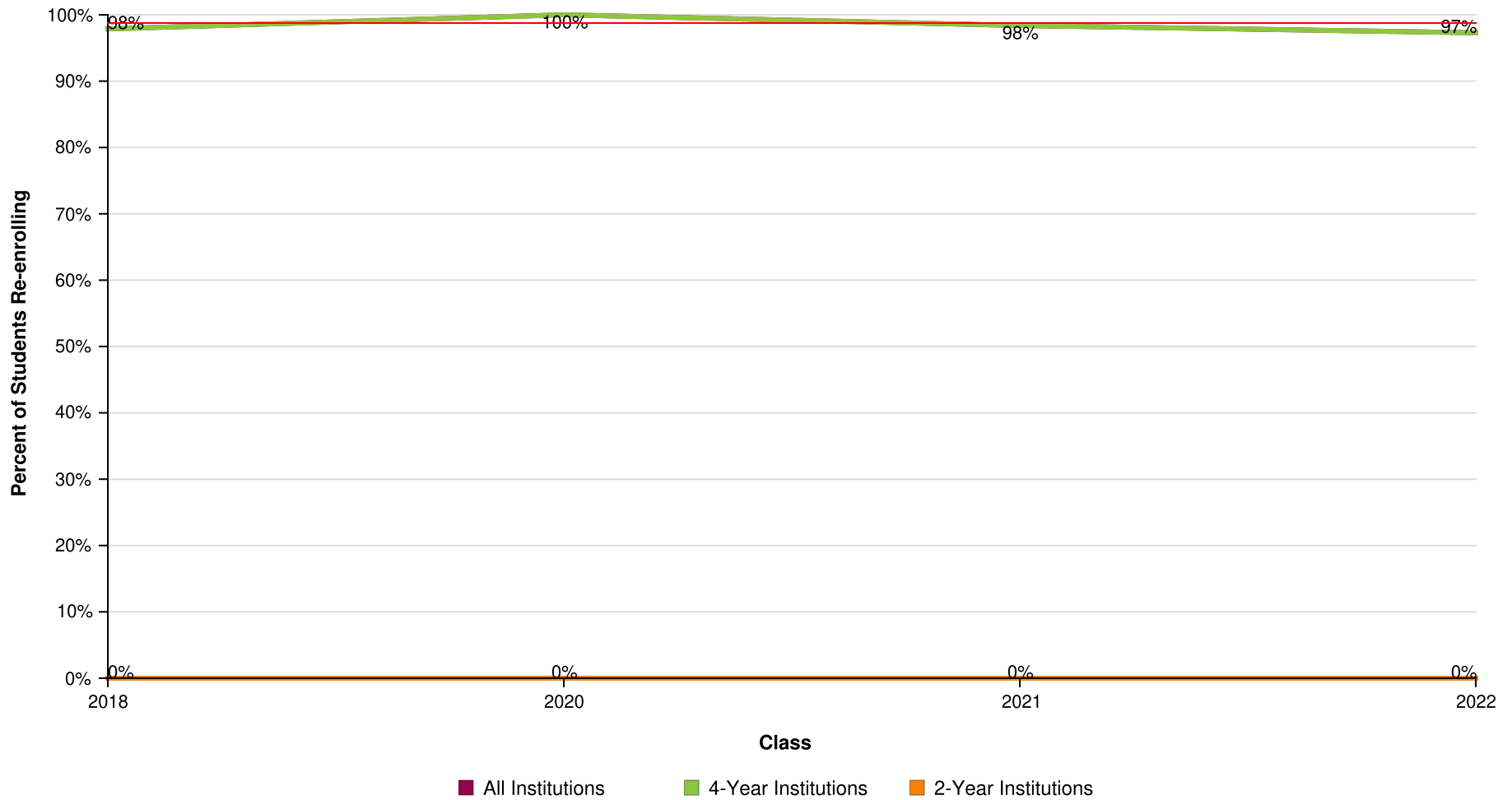

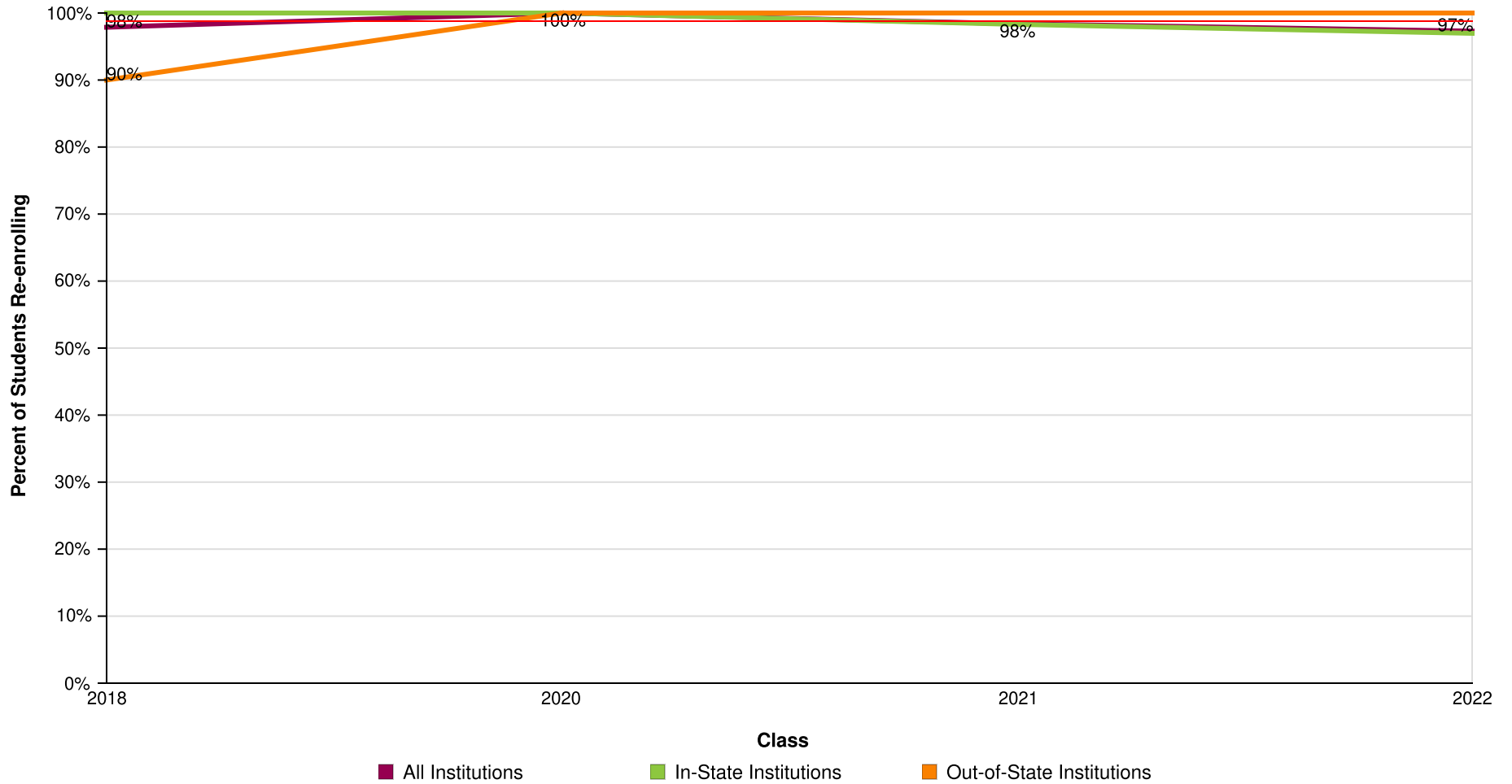

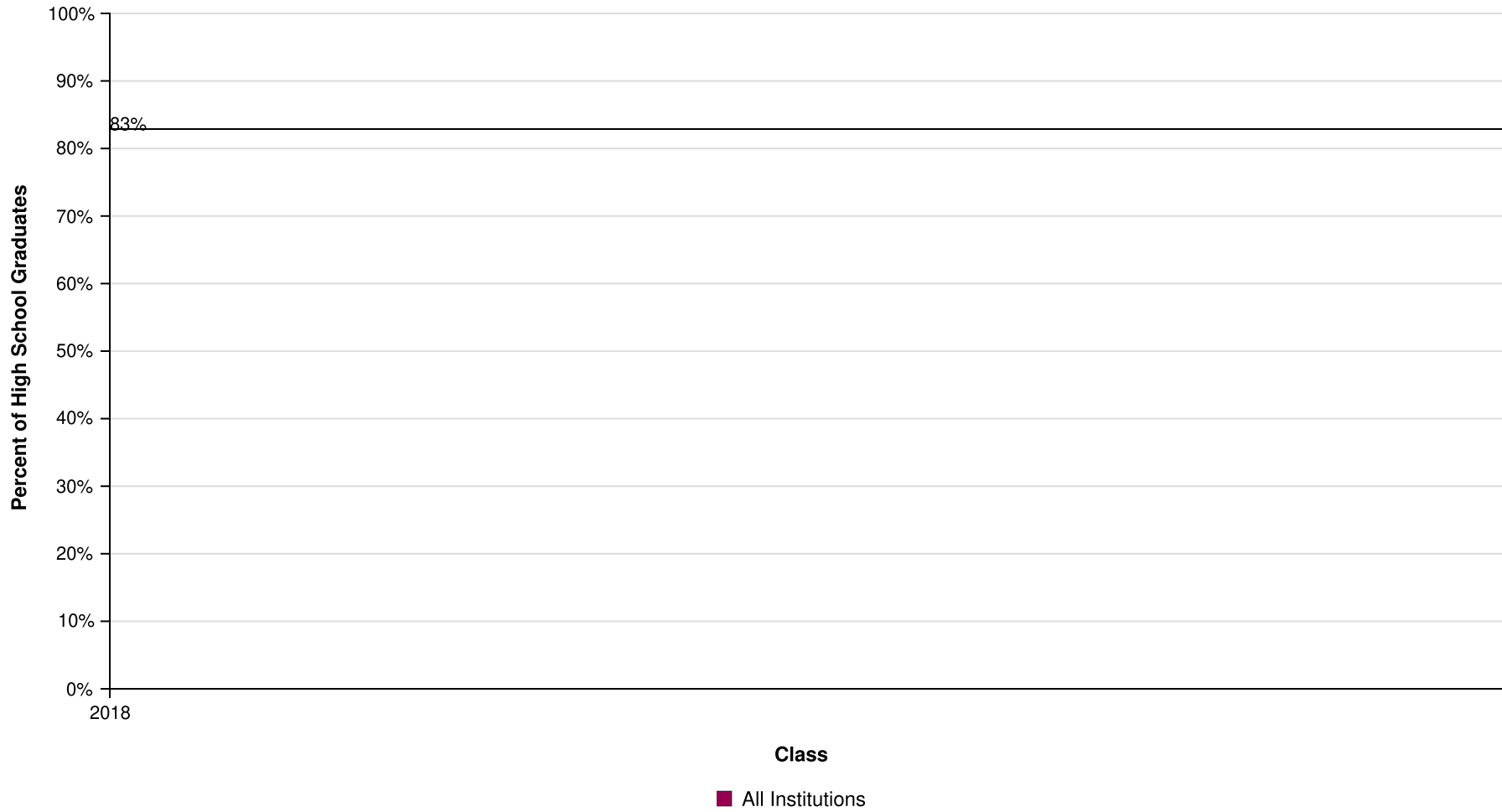

Percent of High School Class Who Completed a Degree Within Six Years

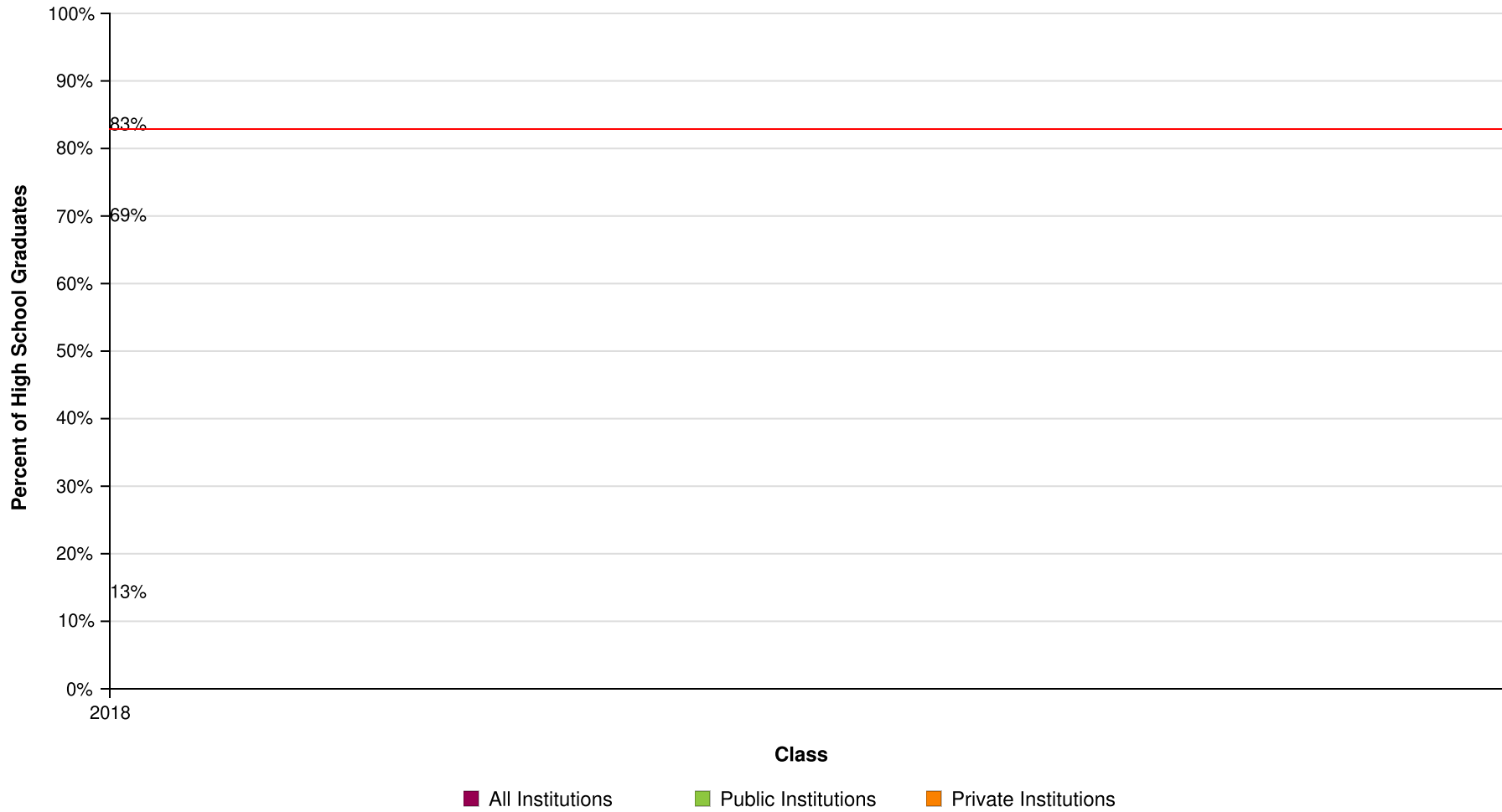

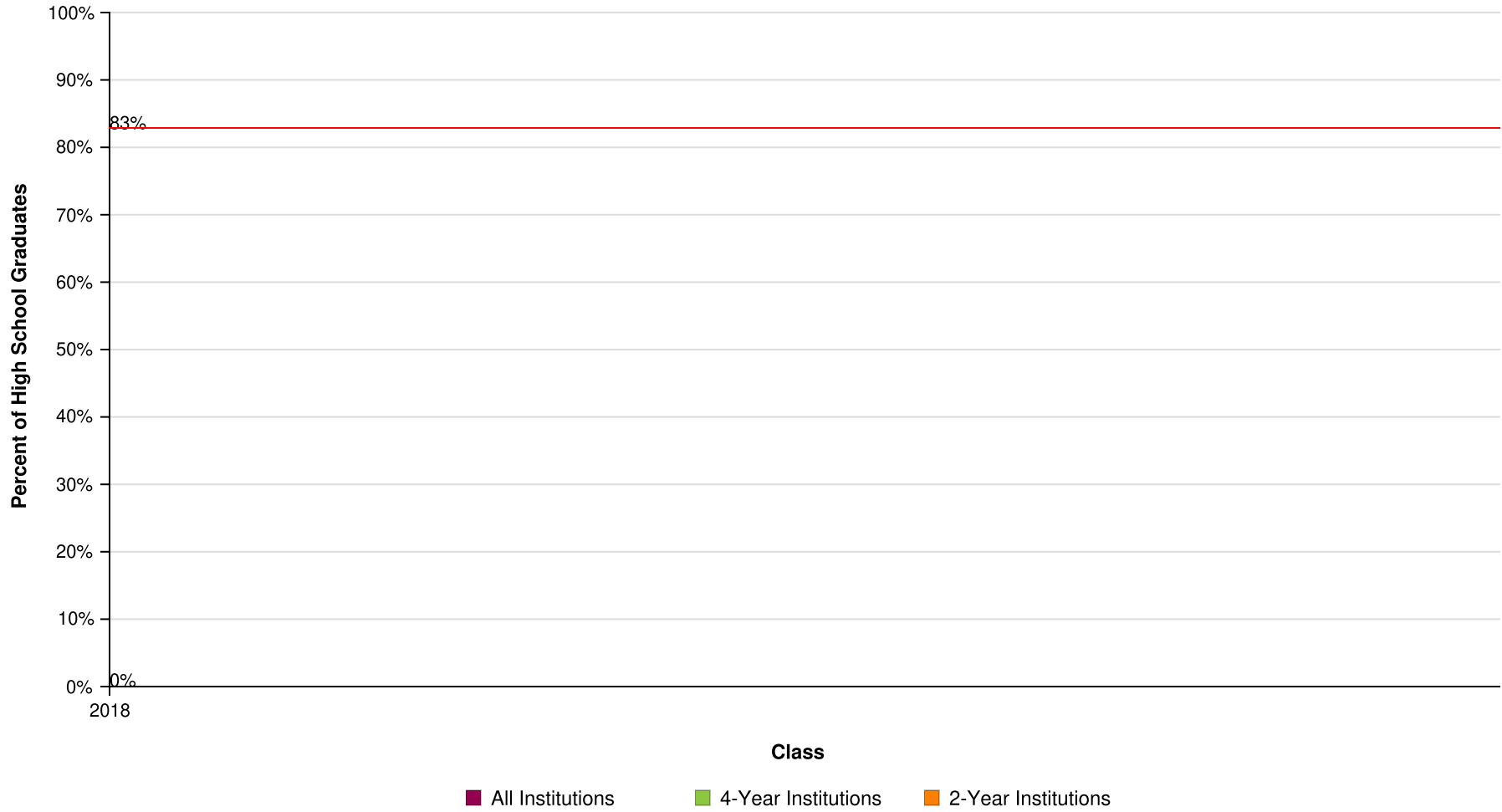

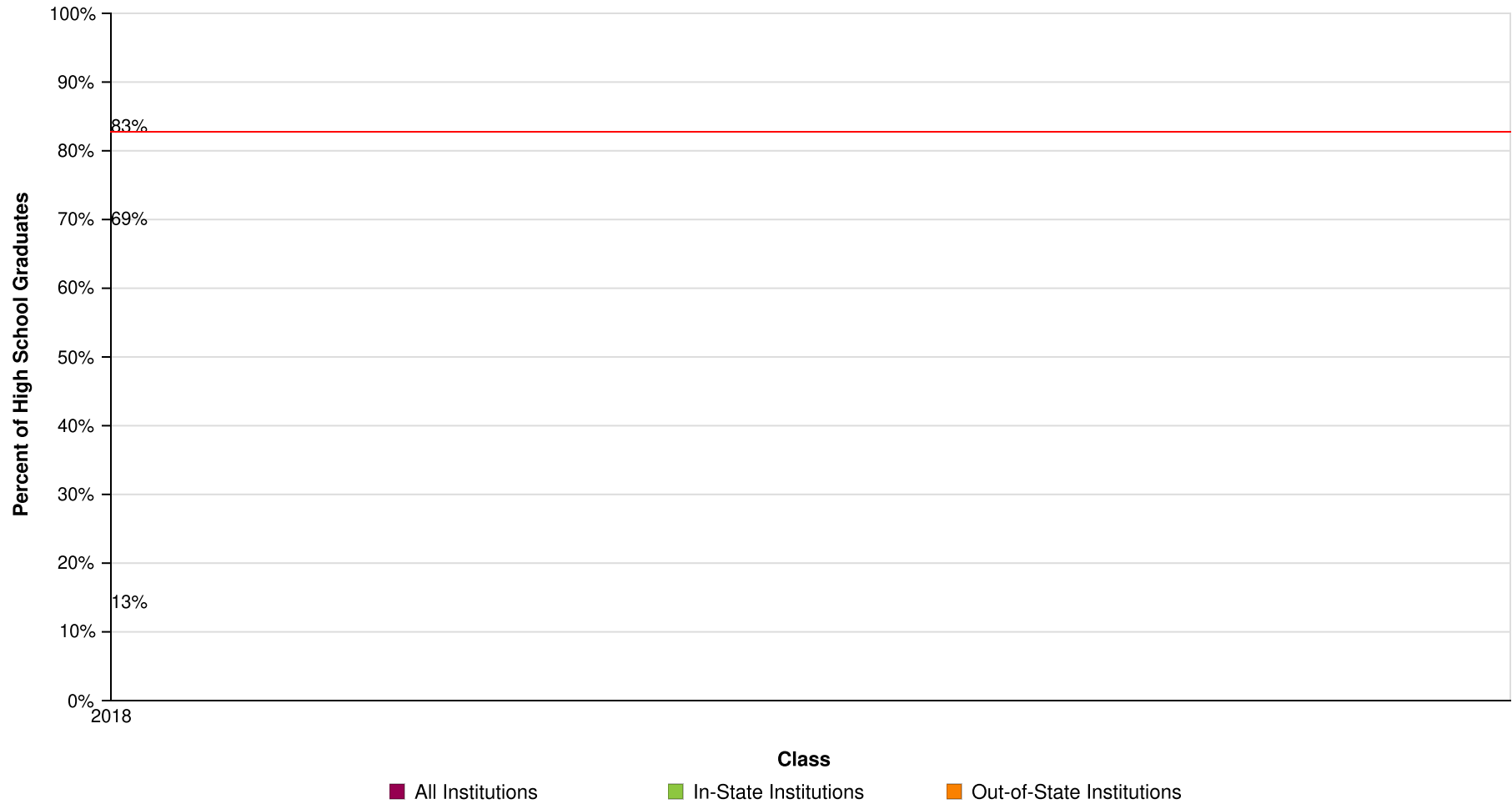

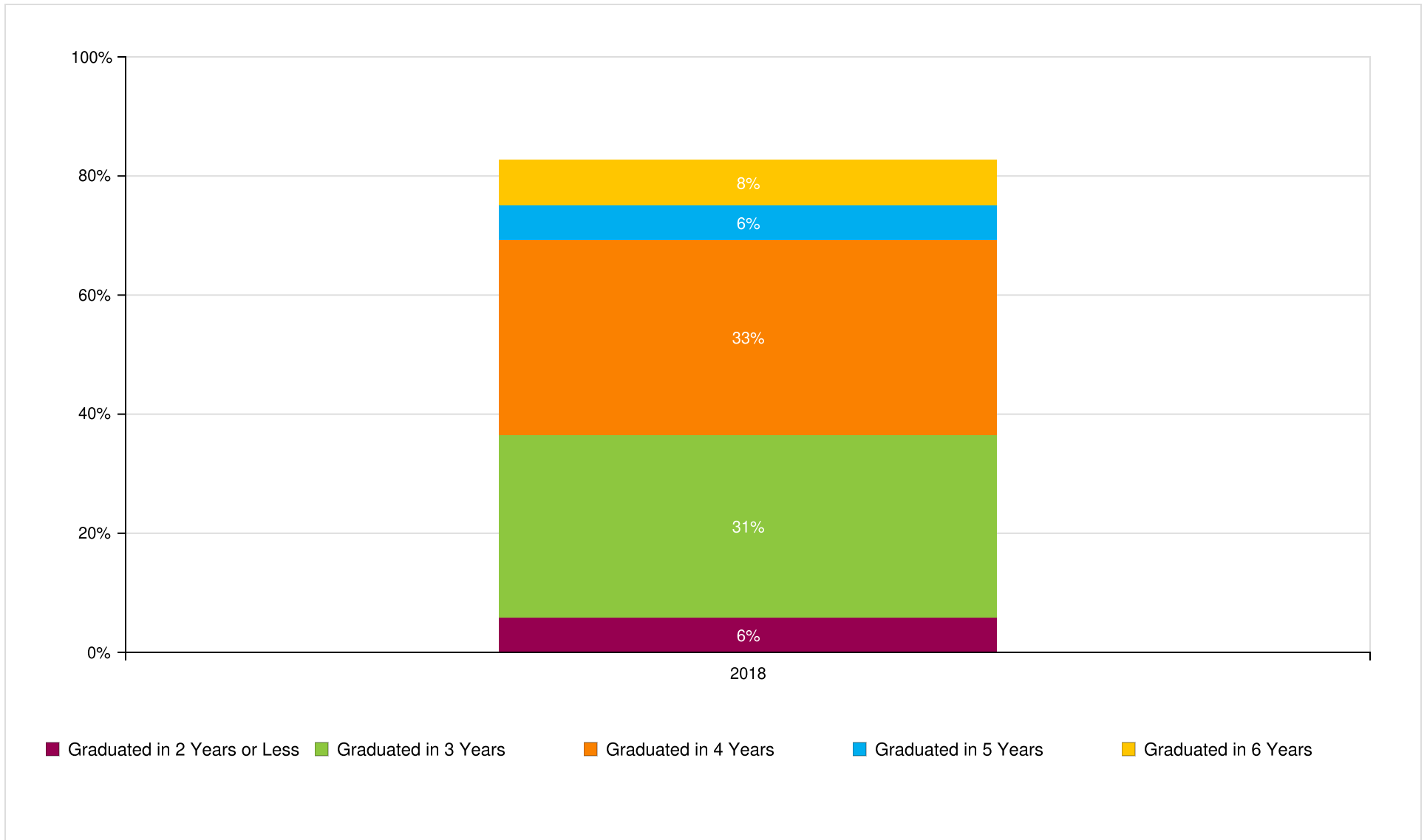

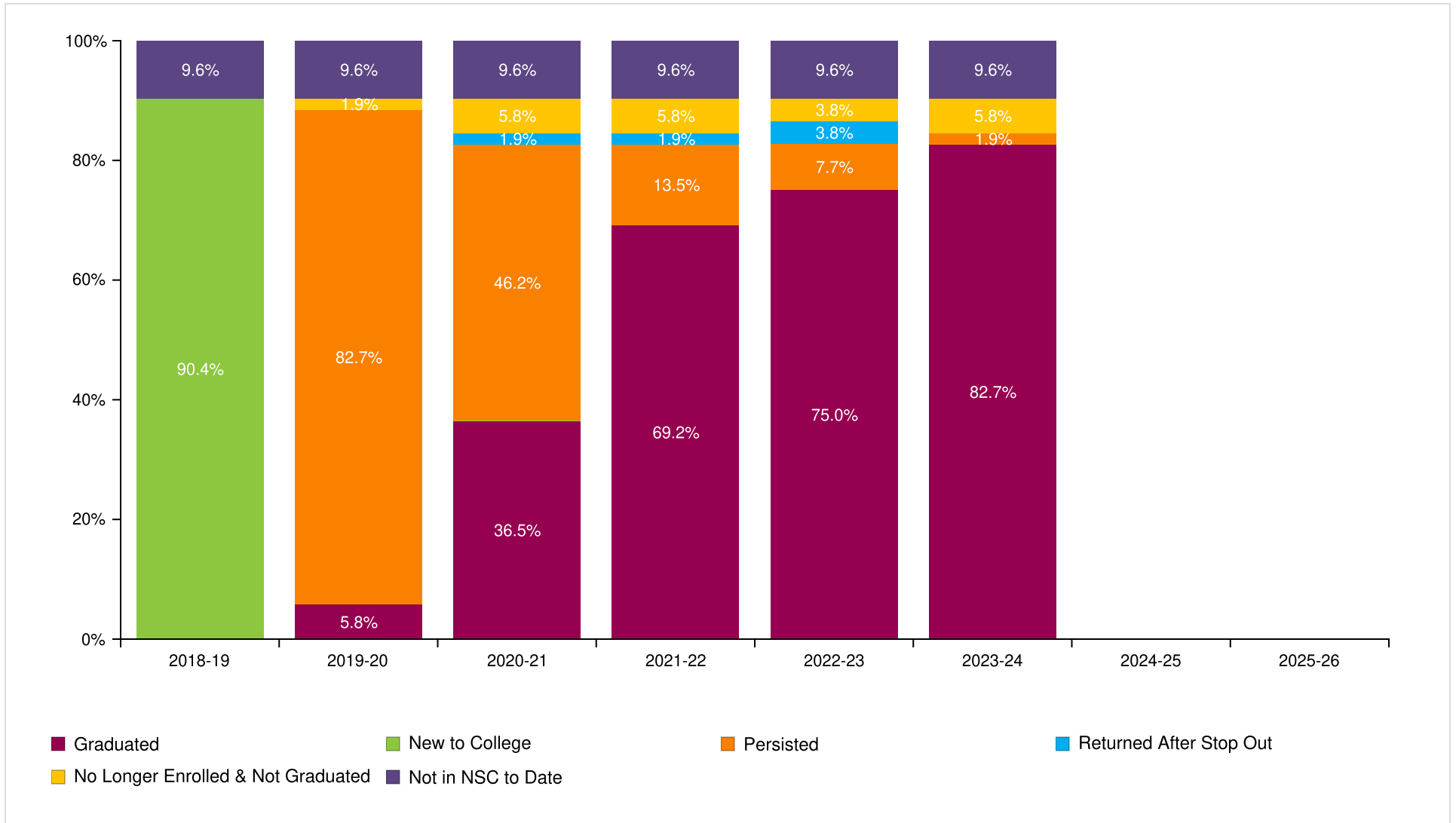

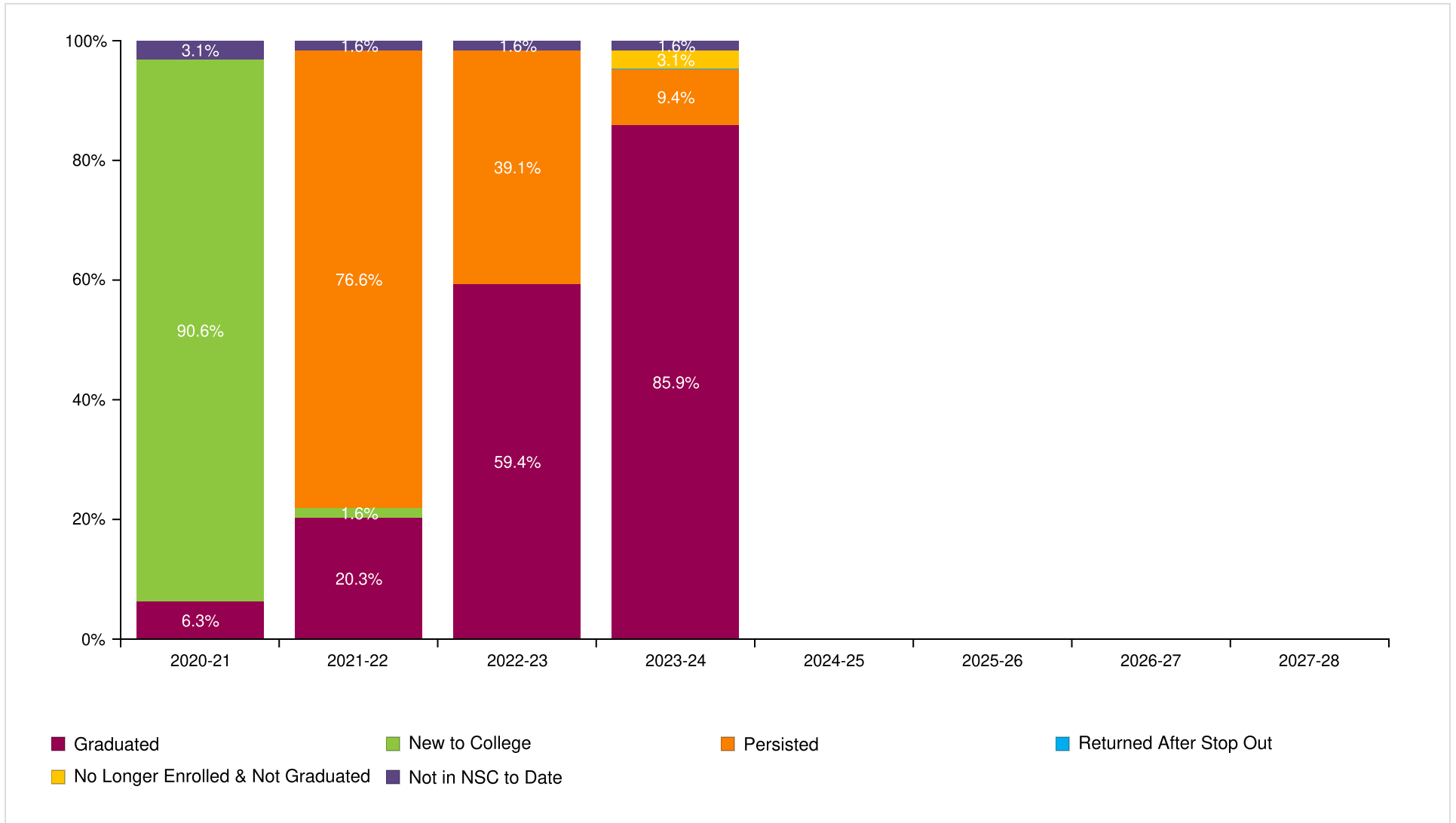

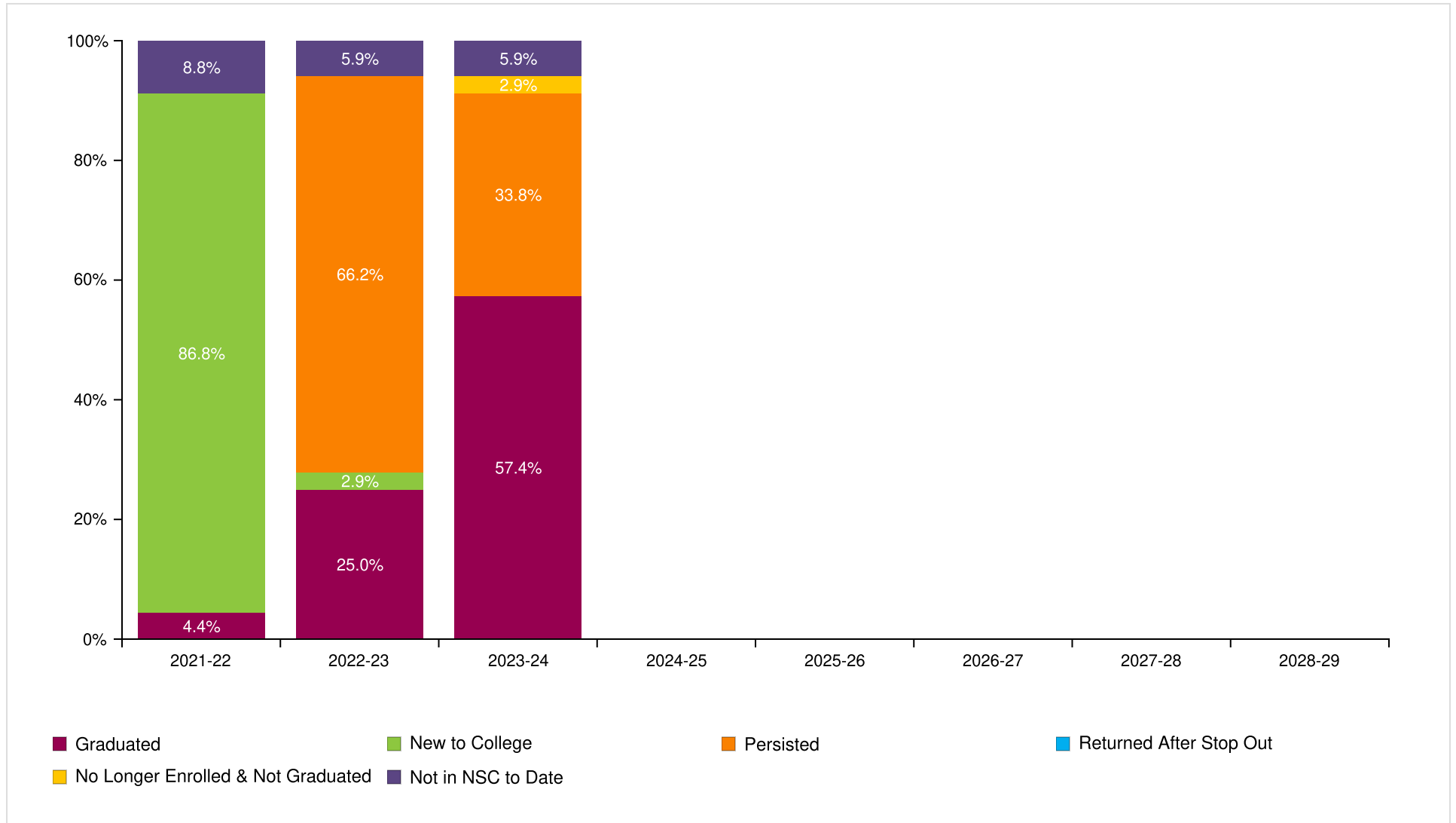

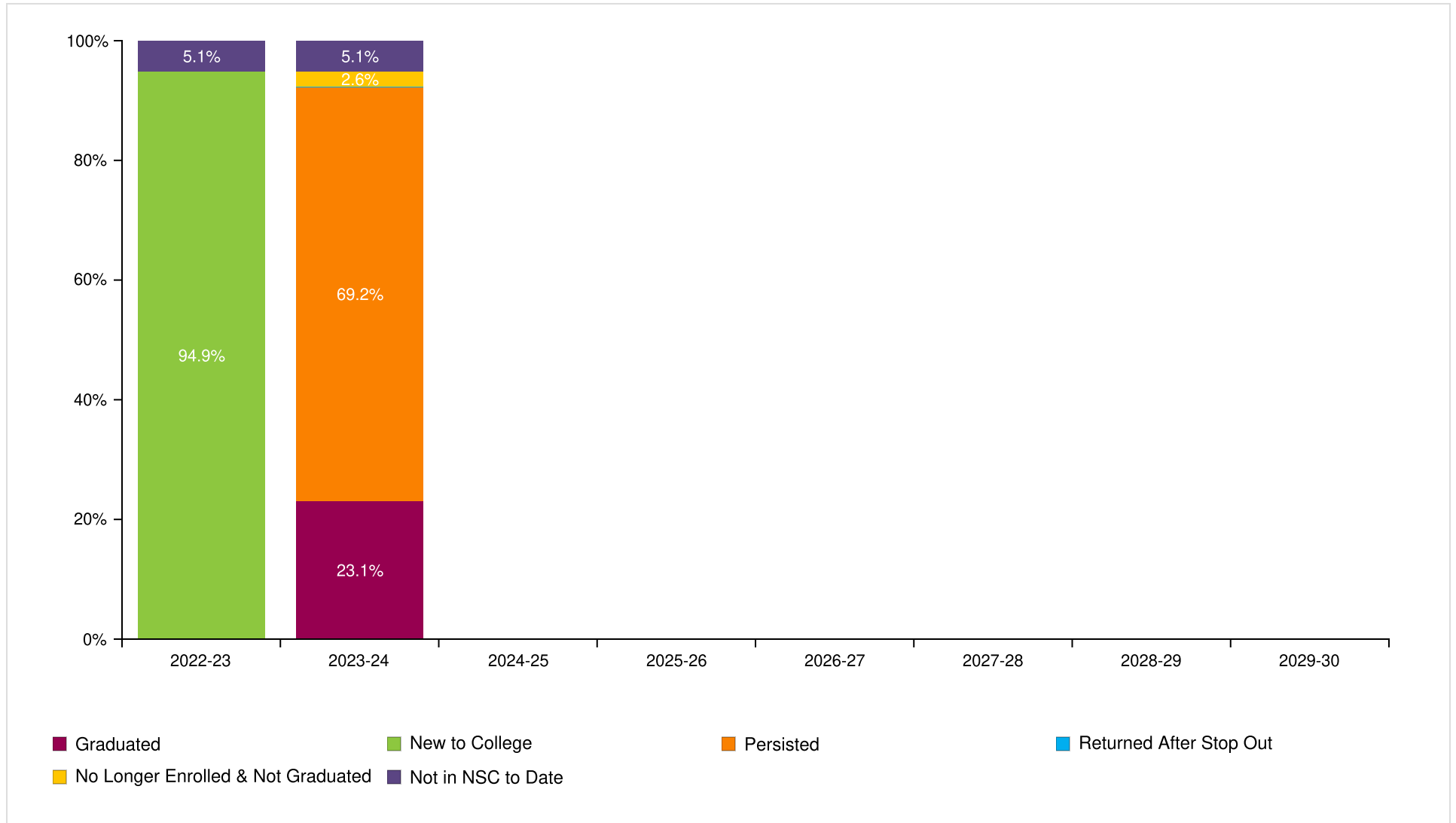

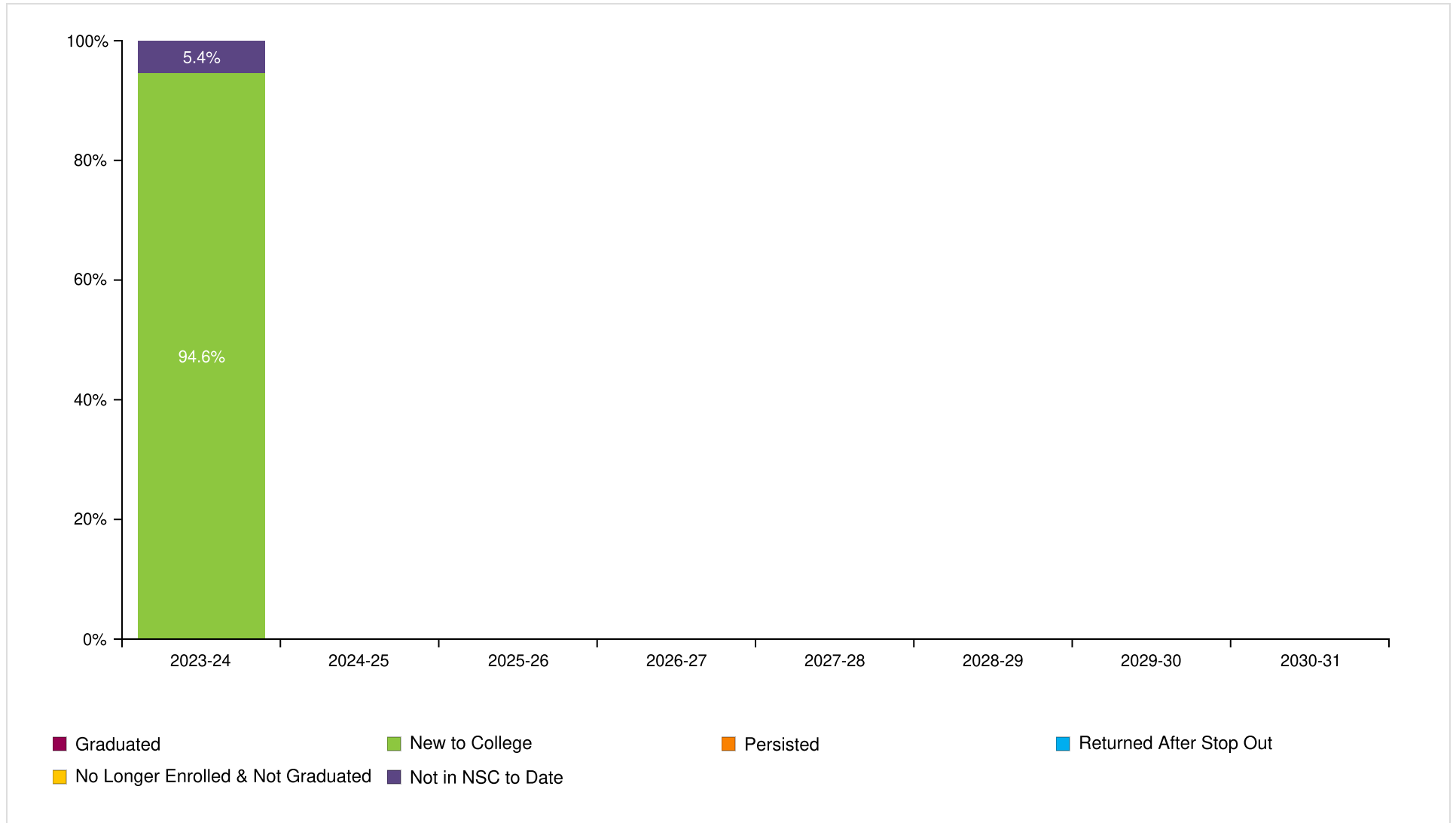
